## IN THE COURT OF APPEALS OF MARYLAND ADMINISTRATIVE ORDER DIRECTING JUDICIAL INFORMATION SYSTEMS TO FACILITATE REPORTING TO THE MARYLAND DEPARTMENT OF TRANSPORTATION – MOTOR VEHICLE ADMINISTRATION

WHEREAS, pursuant to Maryland Rule 16-204, which, effective July 1, 2016, superseded former Rule 16-308, each circuit court clerk or Judicial Information Systems ("JIS") shall promptly transmit the data elements concerning the docketing and disposition of criminal and motor vehicle cases; and

WHEREAS, to facilitate the fulfillment by the State Motor Vehicle Administration ("MVA") of a reporting requirement pursuant to federal regulation, clarification as to the frequency of transmittal of reports of certain traffic dispositions to the MVA by JIS is appropriate,

NOW, THEREFORE, I, Mary Ellen Barbera, Chief Judge of the Court of Appeals and administrative head of the Judicial Branch, pursuant to the authority conferred by Article IV, § 18 of the Maryland Constitution, do hereby order this 19th day of May, 2017, that:

- (a) Pursuant to 49 CFR § 384.209, the MVA is required to notify the licensing entity of the State where the holder of a Commercial Learner's Permit, Commercial Driver's License or a foreign commercial driver's license was issued said permit or license of a conviction of a violation of any State or local law relating to motor vehicle traffic control other than parking, vehicle weight or vehicle defect violations in any vehicle within 10 days of the conviction; and
- (b) Pursuant to 49 CFR § 384.209, the MVA is required to notify the licensing entity of the State where a person is otherwise licensed, but

is not the holder of a Commercial Driver's license, of a conviction of said person, of a violation of any State or local law relating to motor vehicle traffic control – other than a parking violation – in a

Commercial Motor Vehicle within 10 days of the conviction; and

(c) In fulfilling its reporting obligations to the MVA as outlined in Rule 16-204(a)(2), JIS shall transmit to the MVA on a daily basis the aforementioned traffic convictions to assist the MVA in meeting its reporting obligation under the federal regulation; and

(d) The Administrative Order Directing Judicial Information Systems

Department to Facilitate Reporting to the Maryland Department of

Transportation – Motor Vehicle Administration pursuant to former

Maryland Rule 16-308 filed on March 10, 2009, shall be and is

hereby rescinded, effective immediately.
