The State Law Library, Maryland's oldest law library, supports the research activities of the Maryland Judiciary. The Library offers its services and collections to other government entities, the legal community, and the public. In addition to a significant number of legal materials, the Library's collections include Maryland state agency publications, Maryland history, and federal government documents. Staffed by 20 full-time and part-time, professional and paraprofessional employees, the Library stands ready to serve users from all walks of life.

# **Building and Preserving Collections**

### **Digital Collections and Preservation**

The Judiciary Administrative Orders were digitized in PDF-A format and uploaded to their own collection, available on the Library website through Digital Collections. The orders are searchable by keyword and can be browsed by subject. This is an active collection; new orders are added as they are promulgated and the status of old orders updated to current, modified, superseded or expired.

The Library purchased a film scanner and conducted related staff training. The scanner enables the scanning to digital file of a microfilmed file in a fraction of the time printing from a microform printer would take. Library staff are able to use the scanner to digitize lengthy legislative bill files, greatly improving access to legislative history materials. A manual was created to assist users.

Legislative Council Reports and Judiciary Annual Reports have been identified as the next scanning project. A vendor was selected, with the project to begin in FY2017. Documents will continue to be uploaded in searchable PDF-A format and available through the Library's online catalog.

### Collection Maintenance

A large-scale collection management project continued with the withdrawal of non-Maryland print state reporters and law reviews. The Library's map collection was reviewed, resulting in more than 300 older maps donated to the Maryland State Archives, Enoch Pratt Free Library and Maryland Historical Society. Valuable and historic maps were retained, and will be part of a conservation project in FY2017, preparing the items for display in the Library or storage in the Special Collections Room.

### **Special Collections**

Preservation work on the Library's unique material continued with the cleaning and conservation of McKenney and Hall's *History of the Indian Tribes of North America* (E.C. Biddle, 1837). The lithographs, based on original portrait paintings by Charles Bird King, record the appearance of tribal leaders as they came to Washington D.C. to sign peace treaties. Most of King's original paintings were subsequently destroyed in a fire at the Smithsonian. McKenney & Hall's work therefore serves as the remaining record of many prominent leaders of the 19<sup>th</sup> century. The Library's collection includes lithographs from two of the three volumes of this work.

### <u>Database Subscriptions and Access</u>

The Library negotiated a one-year trial subscription to several law-related topical databases from EBSCO:

- Criminal Justice Abstracts with Full Text, covering criminology, criminal justice, criminal law and procedure, corrections and prisons, police and policing, criminal investigation, forensic sciences, history of crime, substance abuse and addiction, and probation and parole;
- Psychology and Behavioral Sciences Collection, covering topics in emotional and behavioral characteristics, psychiatry and psychology, mental processes, and anthropology;
- SocINDEX with Full Text, including information abstracts on criminology, criminal justice, demography, ethnic and racial studies, rural and urban sociology, social psychology, social work, substance abuse, and more.

The Washington Post was added to the Library's list of online newspaper access through Proquest.

Access to the LegalTrac database was discontinued, as evaluation determined that comparable materials through Index to Legal Periodicals and other online services provided adequate coverage.

### E-Books

Library-owned iPad Mini and Kindle devices now make multiple e-books available for patron usage. Lists of titles available on these devices are posted on the Library's web page, <a href="https://www.lawlib.state.md.us/collections/digitalcollections.html">www.lawlib.state.md.us/collections/digitalcollections.html</a>, and include, depending on the device, titles from Lexis, Law Journal Press, Nolo, and the National Consumer Law Center.

### Integrated Library System (ILS)

To meet evolving system needs, the Library transferred its integrated library system from Innovative Interfaces' Millennium to Sierra Services Platform.

## **Promoting Access**

### Reference Statistics

The Library's reference statistics increased by 2% from FY2015, with a final tally of 10,051 interactions recorded. This continues the overall increase in reference work, with a 14% rise since FY2011. Highlights of reference work include:

- The number of interactions with identified public patrons continues to constitute over 60% of the Library's activity. The category "public" excludes judiciary, bar, government, libraries, and students.
- The number of email questions continues to rise as a percentage against the whole, nearing almost 50% of the total number of interactions. The Library receives email reference requests from three streams: directly to the Library's email (<a href="mailto:lawlibrary@mdcourts.gov">lawlibrary@mdcourts.gov</a>); through the People's Law Library website; and through the Maryland AskUsNow 24/7 chat service.

### People's Law Library

June 2016, at the end of the fiscal year, was PLL's biggest month yet, with nearly 29% more pageviews (214,928) than in June 2015.

The fiscal year saw the completed purchase of Lingotek Translation Memory System, which will facilitate the further translation of PLL pages into non-English languages. Translation follows one of two paths: contract and volunteer. Volunteer work is done by translation students, graduates and faculty at Towson University and the University of Maryland at College Park, as well as volunteers from the court and legal community.

The PLL Fellows program continued with the second Fellows class. Matthew Stockwell and Christopher Sweeney, both from the University of Baltimore School of Law, joined the PLL team during the year. Additionally, PLL hosted University of Maryland School of Law, Maryland Public Interest Law Project Summer Fellow, Yelitza Conover.

Content development included 19 new pages in English, as well as five newly-translated Spanish pages. New information included pages on:

- Medicaid in Maryland, and additional information for people with disabilities
- · Replevin and detinue actions in Maryland courts
- Como manejar el robo de identidad
- · Certificate of service
- Matrimonios de hecho o ley comun
- Overview of Maryland law about rental housing
- Three articles on student loans, types of loans, repayment, default, collection, and garnishment
- Four articles on juvenile record expungement
- The right to a lawyer in civil court cases in Maryland
- Maryland language access law: your right to interpretation and translation
