#### Availability and Awards of Funds

The availability of funds is contingent upon the provision of funds in the Maryland Judiciary budget by the Maryland General Assembly for Fiscal Year 2017. Applicants who are awarded funding will receive notice in mid-June of 2016.

#### **Match Requirement**

No matching funds required.

#### **Special Requirements**

Training projects require a template of the pre / post training knowledge assessment tool, which measures skills gained by participants. The tool must be developed and accompany the application.
