## SECTION 1 - GENERAL INFORMATION

### 1.1 PURPOSE

The Administrative Office of the Courts (AOC) issues this Invitation for Bids (IFB) to solicit one contractor to furnish all labor, equipment and supplies necessary to perform daily, weekly, bi-weekly and monthly janitorial services at multiple Annapolis District Court facilities (See Attachment G).

### 1.2 PROCUREMENT OFFICER – POINT OF CONTACT (POC) INFORMATION

The Maryland Judiciary may change the Procurement Officer at any time by written notice.

### 1.3 PROCUREMENT METHOD

The Contract resulting from this IFB will be awarded in accordance with the competitive sealed bids process.

### 1.4 CLOSING DATE

An unbound original must be received by the Procurement Officer by **September 1, 2021 at 4:30 pm EST** in order to be considered. Bids shall be marked **IFB No. K22-0009-40; Annapolis District Court Janitorial Services** on the outside of the envelope along with the **name, address of Bidder and closing date**. An electronic version of the response must be enclosed with the original bid. Electronic versions are to be labeled with the date, IFB title, IFB number, and bidder's name, and packaged with the original copy of the appropriate bid.

Requests for extensions of this date or time will not be granted. Bidders mailing bids should allow enough mail and internal delivery time to ensure timely receipt by the Procurement Officer.

**Bids may not be submitted by e-mail or facsimile.**

### 1.5 ABBREVIATIONS AND DEFINITIONS

For the purposes of this IFB, the following abbreviations or terms have the meanings indicated below:

- a. AOC- Administrative Office of the Courts.
- b. Contract- The Contract attached to this IFB as Attachment A.

- c. Contractor- The awarded Bidder.
- d. Local Time- Time in the Eastern Time Zone.
- e. MBE – Minority Business Enterprise (African American, Native American, Asian Pacific, Subcontinent Asians, and Women-owned Businesses currently so certified by the Maryland State Department of Transportation), and Veteran-owned Small Businesses.
- f. Bidder- An entity that submits a bid in response to this IFB.
- g. Procurement Officer- The Judiciary representative responsible for this IFB, for the determination of contract scope issues, and the only Judiciary representative who can authorize changes to the contract.
- h. IFB- Invitation for Bids for **K22-0009-40** dated **July 30, 2021**, including any and all amendments.
- i. AOC Contract Manager– The Judiciary representative that serves as the technical manager for the resulting contract. The AOC Contract Manager monitors the daily activities of the contract and provides technical guidance to the Contractor.
- j. Judiciary business hours – 8:00 a.m. – 5:00 p.m. Monday – Friday (excluding State holidays and any other days by order of the Chief Judge of the Court of Appeals.).

#### **1.6 PRE-BID CONFERENCE**

A **mandatory** Walk-Through will be held on **August 12, 2021, beginning at 10:00 am**, at 2004 Industrial Drive, Annapolis MD 21401. Attendance at the Conference is **mandatory** in order to facilitate better preparation of proposals. A walking tour will commence immediately following a pre-bid meeting.

As promptly as is feasible subsequent to the Conference, all questions and answers known at that time will be posted to the Judiciary’s procurement website and eMaryland Marketplace Advantage.

In order to assure adequate accommodations at the Walk-Through, please email the Conference Response Form to the attention of the Procurement Officer no later than **August 11, 2021 at 4:00 pm**. The Conference Response Form is included as **Attachment E** to this IFB.

#### **1.7 QUESTIONS**

- 1.7.1 The Procurement Officer shall accept written questions from prospective Bidders. **Please submit all questions to the Procurement Officer by e-mail by August 23, 2021 at 4:00 pm. (See section 1.2).**
- 1.7.2 Based on the availability of time to research, the Procurement Officer shall communicate a timely answer during the pre-bid conference. Answers to all substantive questions that are not clearly specific only to the requestor will be posted on the Judiciary’s procurement website and eMaryland Marketplace Advantage.

## **1.8 Contract Manager**

The Maryland Judiciary may change the Contract Manager at any time by written notice to the Contractor.

## **1.9 CONTRACT TYPE**

The Contract resulting from this solicitation will be a firm fixed price contract.

## **1.10 TERM OF CONTRACT**

The Contract resulting from this IFB shall begin **with contract execution** and extend for a base period of 3 years. The Judiciary shall have the sole right to exercise up to two (2) one (1) year renewal options at its discretion.

## **1.11 BID OPENING**

The Procurement Officer shall hold all bids and modifications in a secure place until the due date, after which time the bids, will be opened in the presence of at least one other Judiciary employee.

## **1.12 DURATION OF BID OFFER**

Bids shall be valid and irrevocable for 180 days following the closing date for this IFB. This period may be extended by written agreement between a Bidder and the Procurement Officer.

## **1.13 REVISIONS TO THE IFB**

If it becomes necessary to revise this IFB before the due date, amendments will be posted on the Judiciary's procurement website and eMaryland Marketplace Advantage.

Acknowledgment of the receipt of all amendments issued to this IFB must be stated in the transmittal letter accompanying the bid submission. Failure to acknowledge receipt of amendments does not relieve the bidder from complying with all terms of any such amendment.

## **1.14 CANCELLATION OF THE IFB; REJECTION OF ALL BIDS**

The Procurement Officer may cancel this IFB, in whole or in part, whenever this action is determined to be in the Maryland Judiciary's best interest.

## **1.15 BID ACCEPTANCE**

The State reserves the right to accept or reject any and all bids, in whole or in part, received in response to this IFB, or to waive or permit cure of minor irregularities. Bidders whose bids are not accepted will be notified in writing.

### **1.16 MULTIPLE OR ALTERNATIVE BIDS**

Neither multiple nor alternative bids will be accepted.

### **1.17 INCURRED EXPENSES**

The Judiciary will not be responsible for any costs incurred by a Bidder in preparing and submitting a bid in response to this IFB.

### **1.18 PROTESTS**

Any protest or dispute related respectively to this solicitation or the resulting Contract shall be subject to the provisions of the Judiciary's Procurement Policy.

### **1.19 PUBLIC ACCESS TO JUDICIAL RECORDS**

A Bidder shall give specific attention to the clear identification of those portions of its proposal that it considers confidential, proprietary commercial information or trade secrets, and provide justification why such materials, upon request, should not be disclosed by the Judiciary under should not be disclosed by the Judiciary under Title 16, Chapter 900 of the Maryland Rules.

Bidders are advised that, upon request for this information from a third party, the Procurement Officer is required to make an independent determination whether the information can be disclosed. Information which is claimed to be confidential is to be placed after the Title Page and before the Table of Contents in the Technical proposal and if applicable in the Financial proposal.

### **1.20 MINORITY BUSINESS ENTERPRISES**

**An MBE Subcontractor participation goal of 15% has been established for this solicitation. Each Bidder shall complete, sign and submit MJUD MBE Form A "Certified MBE Utilization and Fair Solicitation Affidavit" and MJUD MBE Form B "MBE Participation Schedule" at the time it submits its bid response.**

#### **Waiver**

If the Bidder is unable to achieve the MBE participation goal, it shall request a waiver in whole, or in part, of the overall goal by checking the second box on the MJUD MBE FORM A. Failure to indicate the need for a waiver may result in the Judiciary's rejection of the bid.

#### **After Notice of Apparent Award:**

If Bidder is notified that Bidder is the apparent awardee or as requested by the Procurement Officer, Bidder must submit the following documentation within 10 business days of receiving such notice:

- (a) MJUD MBE Form C - Outreach Efforts Compliance Statement;
  - (b) MJUD MBE Form D - MBE Subcontractor Project Participation Statement Affidavit;
  - (c) MJUD MBE Form E - Minority Contractor Unavailability Certificate; and
- additional documentation per the Prime Contractor's Good Faith/Waiver Checklist provide in the IFB, Attachment (if waiver was requested); and



(d) Any other documentation required by the Procurement Officer to ascertain Bidder's responsibility/ Bidder's susceptibility of being selected for award in connection with the certified MBE participation goal.

### **1.21 COMPLIANCE WITH LAW; ARREARAGES**

By submitting a bid in response to this IFB, the Bidder, if selected for award, agrees that it will comply with all Federal, State, and local laws applicable to its activities and obligations under the contract. By submitting a bid in response to this IFB, the Bidder shall be deemed to represent that it is not in arrears in the payment of any obligation due and owing the State of Maryland, including the payment of taxes and employee benefits, and, that it shall not become so in arrears during the term of the contract if selected for contract award.

### **1.22 BID/PROPOSAL AFFIDAVIT**

A completed Bid/Proposal Affidavit must accompany any bid. A copy of this affidavit is included as Attachment B of this IFB.

### **1.23 MANDATORY CONTRACTUAL TERMS**

By submitting a bid in response to this IFB, a Bidder, if selected for award, shall be deemed to have agreed to and accepted all contract terms and conditions set forth in the Judiciary's Standard Contract Agreement included as Attachment A of this IFB. A bid that takes exception to these terms may be rejected.

### **1.24 CONTRACT AFFIDAVIT**

All Bidders are advised that if a Contract is awarded as a result of this solicitation, the successful Bidder will be required to complete a Contract Affidavit. A copy of this Affidavit is included for informational purposes as Attachment C of this IFB. This Affidavit must be provided within five business days of notification of proposed Contract award.

### **1.25 VERIFICATION OF REGISTRATION AND TAX PAYMENT**

Before a corporation can do business in the State of Maryland it must be registered with the Department of Assessments and Taxation, State Office Building, Room 803, 301 West Preston Street, Baltimore, Maryland 21201. It is strongly recommended that any potential Bidder complete registration prior to the due date for receipt of bids. A Bidder's failure to complete registration with the Department of Assessments and Taxation may disqualify an otherwise successful Bidder from final consideration and recommendation for contract award.

### **1.26 BIDDER RESPONSIBILITIES**

The State will enter into contractual agreement only with the selected Bidder. The selected Bidder shall be responsible for all products and services required by this IFB. All subcontractors must be identified and a complete description of their role relative to the bid must be included in the Bidder's response. If a Bidder that seeks to perform or provide the services required by this IFB is subsidiary of another entity, all information submitted by the Bidder, such as but not limited to, references and financial reports, shall pertain exclusively to the Bidder unless the parent organization will guarantee the performance of the subsidiary. If applicable, the bidder's

response must contain an explicit statement that the parent organization will guarantee the performance of the subsidiary.

### **1.27 PAYMENTS BY ELECTRONIC FUNDS TRANSFER**

By submitting a response to this solicitation, the Bidder agrees to accept payments by electronic funds transfer unless the State Comptroller's Office grants an exemption. The selected Bidder shall register using the COT/GAD X-10 Vendor Electronic Funds (EFT) Registration Request Form. Any request for exemption must be submitted to the State Comptroller's Office for approval at the address specified on the COT/GAD X-10 form and must include the business identification information as stated on the form and include the reason for the exemption. ## SECTION 2 - SCOPE OF SERVICES

### 2.1 GENERAL

2.1.1 The Administrative Office of the Courts (AOC), on behalf of the District Court of Maryland (District Court), is issuing this Invitation for Bids (IFB) to select a Contractor to furnish all labor, equipment and supplies necessary to perform daily, weekly, bi-weekly and monthly janitorial services at multiple Annapolis District Court facilities (see Attachment G).

2.1.2 The AOC intends to make a single award as a result of this IFB.

### 2.2 BIDDER MINIMUM QUALIFICATIONS

To be considered responsive, the Bidder must document in its Bid that it satisfies the following Minimum Qualifications:

2.2.1 The Bidder shall have a minimum of two (2) years of experience in providing commercial Janitorial Services, as described in Section 2.3, of similar size and complexity. See Section 3.1.2 for submittal requirements.

### 2.3 SCOPE OF WORK

2.3.1 The Contractor shall furnish all labor, equipment and supplies necessary to perform daily, weekly, bi-weekly and monthly janitorial services at multiple Annapolis District Court facilities in strict conformance with the standards specified in this IFB.

2.3.2 Start time will be determined by the District Court and the Contractor; however, all work is to be completed daily by 4:30 pm. The Contractor will not have access after-hours.

2.3.3 All mechanical rooms, electrical rooms, telephone rooms and any other areas used exclusively by building maintenance personal are excluded from this contract.

2.3.4 The Contractor shall provide, at no additional cost, all supplies, including all janitorial equipment, paper products, and materials necessary to properly perform the duties under the Contract.

2.3.5 The Contractor shall provide, at no additional cost, only those sanitary products, if any, which are compatible with the machines located at the facility. Machine locations, if any will be confirmed during the mandatory walk-through.

2.3.6 **Services to be supplied by District Court:**

- District Court will supply the Contractor with light, heat, power, and hot and cold water for the cleaning of the building (**Note:** Hot water temperature is regulated by the State's energy guideline and cannot be increased above the current guideline temperature).

- District Court will provide janitorial closets, where possible, for the housing of the Contractor's equipment and supplies. These closets will be supplied with locks to safeguard the Contractor's property. These closets must be maintained in a clean, neat and orderly condition by the Contractor. Keys to the janitorial closets will be the responsibility of the Contractor. Should the Contractor lose these or any other building keys, they shall be responsible for the cost of replacing or rekeying the locks affected.
- District Court will supply large trash receptacles (dumpsters) for the final disposal of trash collected in the building. The Contractor shall deposit all trash collected in the building in the receptacle provided and ensure that all lids, doors or other openings to the receptacle are closed and latched.

**2.3.7 Janitorial Tasks/Deficiencies in Work:**

- The buildings must be cleaned at the frequency and to the standards as detailed in these specifications. The District Court designee will determine whether tasks have been performed and that the performance is in accordance with the standards set forth in these specifications. Failure to perform a task or perform a task to the specified standard will result in reduction in the Contractor's monthly invoice.
- Contractor shall promptly correct all apparent and latent deficiencies and/or defects in work, and/or any work that fails to conform to the contract requirements. All corrections shall be made within two (2) calendar days after such rejected defects, deficiencies and/or non-conformances are verbally reported to the Contractor by the Contract Administrator. The Contractor shall bear all costs of correcting such rejected work.
- If the Contractor fails to correct the work within the period specified the District Court may, at its discretion, notify the Contractor, in writing, that the Contractor is subject to contractual default if the corrections are not completed to the satisfaction of the District Court within three (3) calendar days of receipt of the notice.

**Schedule of Deductions:**

1. Daily Restroom Cleaning \$ 30.00 per room, per day
2. Daily Office Cleaning: \$ 5.00 per room, per day
3. Daily Carpet Vacuumed \$ 5.00 per room, per day
4. Trash not properly deposited in the dumpster \$100.00 per occurrence

**2.3.8 Holidays**

All District Court facilities shall be serviced according to the weekend schedule for the following State Holidays, which may be updated, as required:

**2.3.9 Professional Conduct:** While on the District Court of Maryland premises, all Contractor personnel must adhere to the highest professional and ethics standards and must not engage in any activity which is not in the best interest of the District Court of Maryland or is otherwise detrimental to the performance of this contract. The District Court of Maryland shall have the sole right to determine unacceptable behavior, and Contractor must remove and replace unacceptable personnel immediately.

### **2.3.10 Daily Tasks**

Areas: General Offices, Executive Offices, Conference Rooms, Corridors, Break Rooms and Restrooms

#### **Trash:**

- Empty trash cans and remove all trash and wipe container exteriors.
- Collect and remove all litter in the facility
- Empty all designated containers used in collection of recycled aluminum, newspapers or office paper into designated repository located within or near the facility. Return empty containers to original locations. All soiled containers are to be wiped clean.
- All emptied trash cans shall have liners that are free of soil and stains caused by liquids, food, garbage or other substances which creates an odor or will adhere other trash to the side of the liner.
- All trash shall be placed in large plastic bags and deposited in provided dumpster. Large bags are to be closed and tied and free from holes which would allow trash or liquid to escape.
- All items marked as “trash” are removed and boxes are broken down prior to placement in the dumpster
- Dumpster doors are left closed and latched.

#### **Vacuum:**

- Vacuum all carpeted areas and walk-off mats (if supplied).
- All dirt, dust, and trash removed from walk-off mats.
- Roll up walk-off mats to clean floor under and return walk-off mats to their original location.
- Furniture is to be returned to its original position.

#### **Restrooms:**

- Fill all paper towel, toilet paper, hand soap dispensers.
- Clean and disinfect all toilets, urinals and sinks. Leave toilet seat in up position.
- Wash and polish mirrors and enameled surfaces.
- Clean and wipe dry all pipes under sink.
- Damp wipe all doors and door frames with mild non-abrasive detergent

- Damp wipe all wall surfaces and dispensers with proper combination cleaner and disinfectants.
- Damp wipe all baseboards
- Empty sanitary napkin depositories, clean and disinfect

#### 2.3.11 **Weekly Tasks: Mondays and Wednesdays only**

Areas: General Offices, Executive Offices, Conference Rooms, Corridors, Break Rooms and Restroom

- Cleaning of File Room Floors
- All dirt, dust, and trash removal from floors.
- No dirty water or cleaning solution residue or mop marks shall be visible on floor.

#### 2.3.12 **Bi-Weekly Tasks: Wednesdays**

Areas: General Offices, Executive Offices, Conference Rooms, Corridors, Break Rooms and Restroom

- Remove spots from walls. Spot clean stalls, doorjambes and doorplates
- Wet mop all tile floors
- Spot Clean Building Surfaces
  - All vinyl painted or ceramic tile walls and restroom partitioning shall be free of smudges, smears, marks, dirt, fingerprints or other soil. Surfaces will be free of detergent residue, streaks, film or haze.
  - All window ledges, desks, file cabinets, storage cabinets, wooden furniture and all other horizontal surfaces are to be free of dust and trash.
- Spot Clean carpet stains: All carpeted areas. Carpet is free of stains, spots or marks of any kind, which can be removed by carpet cleaners.
- Dust all horizontal surfaces.
  - All window ledges, desks, file cabinets, storage cabinets, wooden furniture and all other horizontal surfaces are to be free of dust and trash.
- Dust all vertical surfaces.
  - All dust removed from all vertical surfaces.

#### 2.3.13 **Monthly Tasks**

Areas: Entrances, General Offices, Executive Offices, Conference Rooms, Corridors, Break Rooms and Restroom

- Clean glass and mirrors
  - Glass shall be free of smears, smudges, fingerprints and be uniform in appearance without residue or haze.
- Vent/Lighting
  - Dust all lighting and ventilation fixtures (outside surfaces)
- Blinds
  - Dust and wipe clean all window blinds.

### 2.3.14 Twice Annually Tasks

**Areas:** All carpeted areas

- Clean and shampoo carpeting
  - Carpet is to be free of all dirt, stains, shampoo residue or other soil which can be removed through proper cleaning
  - Carpet presents a uniform appearance
  - Furniture is restored to its original position

**Areas:** All tile floors inside leased space

- Stripping all old wax buildup and residue from floors
- Thoroughly wash floors
- Apply two coats of wax to floors

## 2.4 DISTRICT COURT ACCESS AND BACKGROUND CHECKS

- A. Site visits to any Judiciary location by contractor personnel must be coordinated by Judiciary staff with the designated site personnel in advance of any visit.
- B. Any contractor personnel working at District Court locations, or on District Court systems or projects, or who have access to Judiciary or State criminal data or systems, must be approved in writing by the Administrative Judge of the District prior to beginning work.
- C. All contractor personnel working at District Court locations, or on Judiciary systems or projects, or who have access to Judiciary or State criminal data or systems, must have a District Court approved criminal background check prior to beginning work with the Judiciary, and may be subject to rejection as a result of the background check.
- D. All contractor personnel assigned to work at the District Court locations shall be required to obtain a Judiciary security identification badge prior to beginning work, and annually thereafter. The contractor is responsible for any fees that may be incurred for initial issuance of the badge and for any replacement.
- E. The badge shall be displayed at all times while on District Court premises. To verify identity, the contractor personnel shall be prepared to provide photo identification upon request by a District Court official.
- F. The contractor personnel are required to immediately notify the JCM, or the Administrative Official of the respective department or office, or the AOC Contracting Officer's Technical Representative (COTR), if their badge is lost or stolen.
- G. The Contractor personnel must notify the Director of District Court Engineering and Central Services Department within one (1) business day if any personnel have been

arrested, indicted, served with a criminal summons, named in a peace or protective order, or named as a defendant in any civil case. The contractor personnel are also required to provide regular updated information regarding the status of any of these actions.

- H. The Director of District Court Engineering and Central Services Department in conjunction with the Procurement Officer may impose restrictive conditions in response to criminal convictions, pending criminal charges, or violation of Judiciary procedures, including removal from contract, and/or restricted access to Judiciary locations or systems.
- I. In the event of a security incident or suspected security incident, the contractor personnel shall immediately notify the Judiciary personnel as follows: Director of District Court Engineering and Central Services Department.
- J. The contractor personnel shall cooperate fully in all security incident investigations.
- K. During the course of the contract, if necessary, for the delivery of goods and services, the Contractor may be provided a Judiciary asset in the form of a cell phone, laptop or other electronic device. Any and all Judiciary devices are the property of the Judiciary and must be returned in working, acceptable condition at the contract's conclusion. If said devices are not in working acceptable conditions, the Contractor may be responsible for the cost of said device(s). Any and all devices must be regularly updated as specified by the manufacturer and JIS and must adhere to all confidentiality guidelines as provided by JIS, the AOC and the JIS Project Manager.
- L. If District Court determines that there is cause for the Contractor's work to be suspended, the Contractor shall take the following steps:
  - a. Immediately cease to represent itself as providing services to the District Court; and
  - b. Deliver to the District Court: (a) a report decrying the current state of the Deliverables provided by the Contractor under this Agreement and any applicable Statements of Work outstanding as of the date of termination; (b) all District Court Confidential information in its possession, or at District Court's option, destroy all such District Court Confidential Information; and (c) all work product to the District Court with seven (7) business days as of the date of termination. Work product includes, but not limited to, works for hire and materials described in §29.3.
  - c. Contractor is responsible for all District Court assets (including but not limited to, laptops, tablets, computers, cell phones, other portable electronic devices, accessories, and peripherals, etc.), that have been provided to the Contractor at the District Court's cost. All District Court issued assets are required to be surrendered to the District Court within five (5) business days of termination of services. Assets will be subject to evaluation and can include normal and expected wear and tear but must be functional and operable. Assets that do not meet this condition may be subject to additional charges to the Contractor. The Contractor shall be liable to the District Court for any and all assets not surrendered.



## **2.5 INSURANCE REQUIREMENTS**

- 2.5.1 The Contractor shall at all times during the term of the Contract maintain in full force and effect, the policies of insurance required by this Section. The Contractor, if requested by AOC, shall provide certified copies of any and all of the policies of insurance to AOC. By submitting a bid in response to this solicitation, the Bidder warrants that it is able to provide evidence of insurance required by this section.
- 2.5.2 Evidence that the required insurance coverage has been obtained may be provided by Certificates of Insurance duly issued and certified by the insurance company or companies furnishing such insurance. Such evidence of insurance must be delivered to the AOC Office of Procurement before the actual implementation of the Contract.
- 2.5.3 All insurance policies shall be endorsed to provide that the insurance carrier will be responsible for providing immediate and positive notice to the AOC in the event of cancellation or restriction of the insurance policy by either the insurance carrier or the Contractor, at least 60 days prior to any such cancellation or restriction. All insurance policies shall name as an additional insured the Administrative Office of the Courts and the Maryland Judiciary.
- 2.5.4 The limits required below may be satisfied by either individual policies or a combination of individual policies and an umbrella policy. The requiring of any and all insurance as set forth in this IFB, or elsewhere, shall be in addition to and not in any way in substitution for all the other protection provided under the Contract.

No acceptance and/or approval of any insurance by AOC, or the Manager of Procurement, shall be construed as relieving or excusing the Contractor from any liability or obligation imposed upon it by the provisions of the Contract.

- A. The Contractor shall maintain Worker's Compensation insurance as required by the laws of the State of Maryland and including Employer's Liability coverage with a minimum limit of \$500,000-each accident; \$500,000 disease-each employee; and \$500,000 disease-policy limit.
- B. Occurrence forms of comprehensive general liability insurance covering the full scope of this agreement with limits not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for personal or bodily injuries and \$1,000,000 per occurrence and aggregate for property damage. A combined single limit per occurrence of \$2,000,000 is acceptable. All policies issued shall include permission for partial or total occupancy of the premises by or for the Administrative Office of the Courts within the scope of this Contract. Such insurance shall include but shall not be limited to, the following:
- C. Comprehensive general liability insurance including a comprehensive broad form endorsement and covering: a) all premises-operations, b) completed operations, c) independent Contractors, d) liability assumed by oral or written contract or agreement, including this contract, e) additional interests of employees, f) notice of

occurrence, g) knowledge of occurrence by specified official, h) unintentional errors and omissions, i) incidental (contingent) medical malpractice, j) extended definition of bodily injury, k) personal injury coverage (hazards A and B) with no exclusions for liability assumed contractually or injury sustained by employees of Contractor, l) broad form coverage for damage to property of the Administrative Office of the Courts, as well as other third parties resulting from completion of the Contractor's services.

D. Comprehensive business automobile liability insurance covering use of any motor vehicle to be used in conjunction with this contract, including hired automobiles and non-owned automobiles.

E. Comprehensive Automobile Liability:

Limit of Liability - \$1,000,000 Bodily Injury  
\$1,000,000 Property Damage

In addition to owned automobiles, the coverage shall include hired automobiles and non-owned automobiles with the same limits of liability.

2.5.5 The insurance required under sub-paragraphs (A), (B), (C) and (D) above shall provide adequate protection for the Contractor against claims which may arise from the Contract, whether such claims arise from operations performed by the Contractor or by anyone directly or indirectly employed by him, and also against any special hazards which may be encountered in the performance of the Contract. In addition, all policies required must not exclude coverage for equipment while rented to other.

2.5.6 Any of the work under the Contract is subcontracted, the Contractor shall require subcontractors, or anyone directly or indirectly employed by any of them to procure and maintain the same coverage's in the same amounts specified above.

## **SECTION 3 – BID FORMAT/BASIS FOR AWARD**

### **3.1 BID FORMAT**

3.1.1 The Bidder must submit a transmittal letter on the bidder's stationery. The sole purpose of the transmittal letter is to transmit the bid. It should be brief and signed by an individual who is authorized to commit the bidder to the services stated in this IFB. Submit the transmittal letter with the following documents to the Issuing Office prior to the submission deadline:

- Completed Bid/Proposal Affidavit (Attachment B)
- Bid Proposal Price Sheet (Attachment F) signed by authorized personnel.
- Contractor Background Check Notice (Attachment H)
- An electronic version of the response must be enclosed with the original bid. Electronic versions are to be labeled with the date, IFB title, IFB number, and bidder's name, and packaged with the original copy of the appropriate bid.

**Bids must be submitted in a sealed envelope that clearly indicates it contains a bid.**

3.1.2 References. At least three (3) references are requested from customers who are capable of documenting the Bidder's ability to provide the goods and services specified in this IFB. References used to meet and Minimum Qualifications may be used to meet this request. Each reference shall be from a client for whom the Bidder has provided goods and services within the past five (5) years and shall include the following information:

- 1) Name of client organization;
- 2) Name, title, telephone number, and e-mail address, if available, of point of contact for client organization; and
- 3) Value, type, duration, and description of goods and services provided.

### **3.2 BASIS FOR AWARD**

Upon determination of the most favorable bid, review of the bid for responsiveness, and satisfaction that the bidder is responsible, the Procurement Officer shall, after obtaining all required approvals, award the Contract to that bidder.

STANDARD TERMS AND CONDITIONS**

This Contract is made this \_\_\_\_\_ day of \_\_\_\_\_ **YEAR**, by and between the Administrative Office of the Courts (the “AOC”) in the State of Maryland and **(Company Name), (Company Address)** (the “Contractor”) with Federal Taxpayer Identification Number **XX-XXXXXXX**.

In consideration of the mutual covenants and promises herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the AOC and the Contractor agree as follows:

**1. Scope of Contract**

1.1 The Contractor shall provide **(Add language to fit the procurement)** (hereinafter “Goods” or “Services”), and other deliverables in accordance with the terms and conditions of this Contract and the following Exhibits, which are attached to this Contract and incorporated as part of this Contract:

Exhibit A: Contract Affidavit

Exhibit B: Invitation for Bids dated **(Enter IFB Date)** and all amendments and exhibits thereto (collectively referred to as the “IFB”)

Exhibit C: Contractor’s Bid dated **(Enter Contractors Bid Date)** (collectively referred to as “the Bid”)

Exhibit D: Non-Disclosure Agreement

1.2 If there are any inconsistencies between the Contract and any of the Exhibits, the terms of this Contract shall prevail. If there are any inconsistencies between Exhibit B and Exhibit C, Exhibit B shall prevail.

1.3 No other order, statement, or conduct of the Procurement Officer or of any other person shall be treated as a change or entitle the Contractor to an equitable adjustment under this section. Any modification to this Contract must first be approved in writing by the Procurement Officer, subject to any additional approvals required by State law and the Maryland Judiciary’s Procurement Policy and procedures.

- 1.4 Except as otherwise provided in this Contract, if any order causes an increase or decrease in the Contractor's cost of, or the time required for, the performance of any part of the work, an equitable adjustment in the Contract price shall be made and the Contract modified in writing accordingly. The Contractor must assert in writing its right to an adjustment under this section within thirty (30) days of receipt of a written change order and include a written statement setting forth the nature and cost of such claim. No claim by the Contractor shall be allowed if asserted after final payment under this Contract.
- 1.5 Failure to agree to an adjustment under this section shall be a dispute under the Disputes clause. Nothing in this section shall excuse the Contractor from proceeding with the Contract as changed.

## **2. Term of the Contract**

The Contract resulting from this IFB shall begin upon execution and continue until delivery and acceptance of all items. All prices for rates and terms as offered on the Bid Sheet are binding on the Contractor for the term of the Contract.

Audit, confidentiality, document retention, and indemnification obligations under this Contract shall survive the expiration or termination of the Contract.

## **3. Consideration and Payment**

- 3.1 In consideration of the satisfactory performance of the Services, the AOC shall pay the Contractor in accordance with the terms of this Contract and at the rate specified on the Bid Sheet. Except with the express written consent of the Procurement Officer, total payments to the Contractor pursuant to the original form of this Contract may not exceed \$..... (the "NTE Amount").
- 3.2 All invoices shall be submitted within thirty (30) calendar days after the completion and acceptance by the AOC for each deliverable and include the following information: name and address of the AOC; vendor name; remittance address; federal taxpayer identification or (if owned by an individual) his/her social security number; invoice period; invoice date; invoice number; amount due; and the deliverable ID number for the deliverable being invoiced. Additional information may be required in the future. Invoices submitted without the required information will not be processed for payment until the Contractor provides the requested information.
- 3.3 Payments to the Contractor for each deliverable should be made no later than thirty (30) days after the acceptance of the deliverable and receipt of a proper invoice from the Contractor. Charges for late payment of invoices are prohibited.
- 3.4 In addition to any other available remedies, if, in the opinion of the Procurement Officer, the Contractor fails to perform in a satisfactory and timely manner, the Procurement Officer may refuse or limit approval of any invoice for payment and may cause payments

to the Contractor to be reduced or withheld until such time as the Contractor meets performance standards as established by the Procurement Officer in accordance with this Contract. Final payment shall not be construed as a waiver or termination of any rights and remedies available to AOC for any failure of Contractor to perform the Contract in a satisfactory and timely manner.

#### **4. Warranties**

The Contractor hereby represents and warrants that:

- 4.1 It is qualified to do business in the State of Maryland and that it will take such action as may be necessary to remain so qualified;
- 4.2 It shall comply with all federal, State and local laws applicable to its activities and obligations under this Contract;
- 4.3 It shall obtain, at its expense, all licenses, permits, insurance, and governmental approvals, if any, necessary to the performance of its obligations under this Contract; and
- 4.4 It is responsible for all acts and omissions of its agents, employees, and subcontractors, including, but not limited to violations of the Non-Disclosure Agreement.

#### **5. Patents and Copyrights, if applicable**

- 5.1 If the Contractor furnishes any design, device, material, process, code, or other item that is covered by a patent or copyright or which is proprietary to or a trade secret of another, the Contractor shall obtain the necessary permission or license for the AOC's use of such item or items.
- 5.2 The Contractor shall defend or settle, at its own expense, any claim or suit against the State, AOC, or their employees acting within the scope of employment, alleging that any such item furnished by the Contractor infringes any patent, trademark, copyright, or trade secret. The Contractor also shall pay all damages and costs that by final judgment might be assessed against the State, AOC, or their employees acting within the scope of employment, due to such infringement and all attorney fees and costs incurred by the State to defend against such a claim or suit.
- 5.3 If any products furnished by the Contractor become, or in the Contractor's opinion are likely to become the subject of a claim of infringement, the Contractor shall, at its option and expense: (a) procure for the AOC the right to continue using the applicable item; (b) replace the product with a non-infringing product substantially complying with the item's specifications, or; (c) modify the item so that it becomes non-infringing and performs in a substantially similar manner to the original item.

5.4 If the Contractor obtains or uses for purposes of this Contract any design, device, material, process, code, supplies, equipment, text, instructional material, services or other work, the Contractor shall indemnify the AOC, its officers, agents, and employees with respect to any claim, action, cost, or judgment for patent, trademark, or copyright infringement, arising out of the possession or use of any design, device, material, process, supplies, equipment, text, instructional material, services or other work covered by any Contract awarded.

## **6. Non-hiring of Employees**

No employee of the Maryland Judiciary or any unit hereof whose duties as such employee include matters relating to or affecting the subject matter of this Contract shall become or be an employee of the Contractor, as provided under MD Code, General Provisions § 5-501, *et seq.*

## **7. Non-employment of Contractor's Employees**

Nothing in this contract shall be construed to create an employment relationship between the AOC and any employee of either the Contractor or the Contractor's subcontractors.

## **8. Disputes**

Any claim regarding the proper interpretation of this Contract shall be submitted, in writing, to the Procurement Officer, together with a statement of grounds supporting the Contractor's interpretation. Pending resolution of a claim by the Procurement Officer, the Contractor shall proceed diligently with the performance of the Contract in accordance with the Procurement Officer's decision. An adverse decision to the Contractor may be appealed by the Contractor to the AOC within fifteen (15) days of the Procurement Officer's decision for adjudication pursuant to the Maryland Judiciary's Procurement Policy.

## **9. Maryland Law**

The place of performance of this Contract shall be the State of Maryland. This Contract shall be performed, construed, interpreted, and enforced according to the laws of the State of Maryland, including MD Code, State Government § 12-204. No action relating to this contract shall be brought in any forum other than Maryland, whether or not the AOC is a party to such an action.

## **10. Non-discrimination in Employment**

Contractor shall not discriminate on the basis of race, color, religion, ancestry, national origin, sex, age, marital status, sexual orientation, gender identity, genetic information, or an individual's refusal to submit to a genetic test or make available the results of a genetic test or on the basis of disability, or other unlawful forms of discrimination in the solicitation, selection, hiring, or commercial treatment of employees, subcontractors, vendors, suppliers, or commercial customers, nor shall the Contractor retaliate against any person for reporting instances of such discrimination.



The Contractor shall provide equal opportunity for subcontractors, vendors, and suppliers to participate in all of its public sector and private sector subcontracting and supply opportunities, provided that nothing contained in this clause shall prohibit or limit otherwise lawful efforts to remedy the effects of marketplace discrimination that have occurred or are occurring in the marketplace.

The Contractor understands and agrees that a material violation of this clause shall be considered a material breach of this Contract and may result in termination of this Contract, disqualification of the Contractor from participating in AOC contracts, or other sanctions. This clause is not enforceable by or for the benefit of, and creates no obligation to, any third party. As a condition of entering into this Contract, the Contractor represents and warrants that every subcontract it has entered into or will enter into for the performance of any of the work under this Contract shall include a clause identical to the non-discrimination language above.

### **11. Contingent Fee Prohibition**

The Contractor warrants that it has not employed or retained any person, partnership, corporation, or other entity, other than a bona fide employee, bona fide agent, bona fide salesperson, or commercial selling agency working for the Contractor to solicit or secure this Contract, and that it has not paid or agreed to pay any person, partnership, corporation, or other entity, other than a bona fide employee, bona fide salesperson, or commercial selling agency, any fee or other consideration contingent on the making of this Contract.

### **12. Non-availability of Funding**

If the Maryland General Assembly fails to appropriate funds or if funds are not otherwise made available for continued performance for any fiscal year of this Contract succeeding the first fiscal year, this Contract shall be canceled automatically as of the beginning of the fiscal year for which funds were not appropriated or otherwise made available; provided, however, that this will not affect either the AOC's rights or the Contractor's rights under any termination clause in this Contract. The effect of termination of the Contract hereunder will be to discharge both the Contractor and the AOC from future performance of the Contract, but not from their rights and obligations existing at the time of termination. The Contractor shall be reimbursed for the reasonable value of any non-recurring costs incurred but not amortized in the price of the Contract. The AOC shall notify the Contractor as soon as it has knowledge that funds may not be available for the continuation of this Contract for each succeeding fiscal period beyond the first.

### **13. Termination for Cause**

If Contractor fails to fulfill its obligations under this Contract properly and on time, or otherwise violates any provision of the Contract, the AOC may terminate the Contract by written notice to the Contractor. The notice shall specify the acts or omissions relied upon as cause for termination. All finished or unfinished work provided by the Contractor shall, at the AOC's option, become the AOC's property. The AOC shall pay the Contractor fair and equitable compensation for satisfactory performance prior to receipt of notice of termination, less the amount of damages caused by the Contractor's breach. If the damages are more than the

compensation payable to the Contractor, the Contractor will remain liable after termination, and the AOC can affirmatively collect damages.

#### **14. Termination for Convenience**

The performance of work under this Contract may be terminated by the AOC in accordance with this clause in whole or, from time to time, in part whenever the AOC determines that such termination is in the AOC's best interest. The AOC will pay all reasonable costs associated with this Contract that the Contractor has incurred up to the date of termination, and all reasonable costs associated with termination of the Contract; however, the Contractor shall not be reimbursed for any anticipatory profits that have not been earned up to the date of termination.

#### **15. Delays and Extensions of Time**

The Contractor agrees to perform this Contract continuously and diligently. No charges or claims for damages shall be made by the Contractor for any delays or hindrances, regardless of cause, in the performance of services under this Contract. Time extensions may be granted only for excusable delays that arise from unforeseeable causes beyond the control and without the fault or negligence of the Contractor, including but not restricted to acts of God, acts of the public enemy, acts of the State in either its sovereign or contractual capacity, acts of another Contractor in the performance of an AOC contract, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, or the delay of a subcontractor or supplier arising from unforeseeable causes beyond the control and without the fault or negligence of either the Contractor or the subcontractor or supplier.

#### **16. Suspension of Work**

The AOC may direct the Contractor in writing to suspend, delay, or interrupt all or any part of its performance for such period of time as the Procurement Officer may determine to be appropriate for the AOC's convenience.

#### **17. Pre-existing Law**

The applicable statutes and regulations of the State of Maryland are hereby incorporated in this Contract.

#### **18. Financial Disclosure**

The Contractor shall comply with the provisions of MD Code, State Finance and Procurement § 13-221.

#### **19. Political Contribution Disclosure**

The Contractor shall comply with Title 14 of the Election Law of Maryland.

## **20. Right to Audit**

- 20.1 The Contractor shall establish a reasonable accounting system, shall retain and maintain all records and supporting documents and materials relating to this Contract for five (5) years after final payment by the AOC hereunder and shall make them available for inspection and audit by authorized representatives of the State of Maryland and/or the AOC, including the Procurement Officer or the Procurement Officer's designee, at all reasonable times. The Contractor shall cooperate fully with any audits or investigations conducted by the State of Maryland and/or the AOC.
- 20.2 The AOC reserves the right, at its sole discretion at any time, to perform an audit of the Contractor's performance under this Contract. Auditing is defined as an independent objective assurance and consulting activity performed by qualified personnel including, but not limited to, the AOC's Internal Audit Department, to determine by investigation, examination, or evaluation of objective evidence from data, statements, records, operations, and performance practices (financial or otherwise), the Contractor's compliance with the Contract, including but not limited to adequacy and compliance with established procedures and internal controls over the Contract services being performed for the AOC.
- 20.3 Upon three (3) business days' notice, the Contractor shall provide the AOC reasonable access to their respective records to verify compliance with the terms of the Contract. The AOC may conduct these audits with any or all of its own internal resources or by securing the services of a third-party accounting or audit firm, solely at the AOC's election. The AOC may copy, at its own expense, any record related to the services performed and provided under this Contract.
- 20.4 The right to audit shall include the Contractor's subcontractors including, but not limited to, any lower tier subcontractor(s) that provide essential support to the Contract services. The Contractor and/or subcontractor(s) shall ensure the AOC has the right to audit such subcontractor(s).

## **21. Liability for Loss of Data**

In the event of loss of any data or records, which such loss is due to the error, negligence, or intentional act or omission of the Contractor, whether or not related to the performance of this contract, the Contractor shall be responsible, irrespective of cost to the Contractor, for recreating all such lost data or records in a manner, format, and time-frame acceptable to the AOC.

## **22. Subcontracting and Assignment**

The Contractor may subcontract any portion of the services provided under this Contract by obtaining the Procurement Officer's prior written approval. The Contractor may assign this Contract, or any of its rights or obligations hereunder, only with the Procurement Officer's prior written approval. Any such subcontract or assignment shall be subject to any terms and conditions that the Procurement Officer deems necessary to protect the interest of the State of

Maryland. The AOC shall not be responsible for the fulfillment of the Contractor's obligations to subcontractors.

### **23. Novation and Assignment**

If the Contractor sells its interests in the Contract to another business entity (hereinafter "assignee"), the original Contractor must notify the AOC of the assignment within five (5) business days. The Contractor's assignee and the AOC must sign a novation agreeing to continue with the original terms of the Contract. The assignee must accept all liability on behalf of the Contractor and submit the necessary documentation (i.e. Certificate of Insurance) with identical insurance coverage to the Contractor to the Procurement Officer within five (5) business days of notifying the AOC of the assignment.

### **24. Overtime**

Contractors shall be paid according to the IFB. If overtime pay is not provided for in the IFB, then the Contractor shall not be provided compensation for overtime unless otherwise agreed to in advance, in writing, by the Procurement Officer.

### **25. Indemnification**

- 25.1. The Contractor shall hold harmless and indemnify the AOC from and against any and all losses, damages, claims, suits, actions, liabilities, and/or expenses, including, without limitation, attorneys' fees and costs and disbursements of any character that arise from, are in connection with or are attributable to the performance or nonperformance of the Contractor or its subcontractors under this contract.
- 25.2 The AOC has no obligation to provide legal counsel or defense to the Contractor or its subcontractors in the event that a suit, claim or action of any character is brought by any person not party to this Contract against the Contractor or its subcontractors as a result of or relating to the Contractor's obligations under this Contract.
- 25.3 The AOC has no obligation for the payment of any judgments or the settlement of any claims against the Contractor or its subcontractors as a result of or relating to the Contractor's obligations under this Contract.
- 25.4 The Contractor shall immediately notify the Procurement Officer of any claim, suit or action made or filed against the Contractor or its subcontractors regarding any matter resulting from or relating to the Contractor's obligations under the

Contract, and shall cooperate, assist and consult with the AOC in the defense or investigation of any such claim, suit, or action.

**26. Limitation of Liability**

Without prejudice to the AOC's right to pursue non-monetary remedies, Contractor shall be liable as follows:

- 26.1 For infringement of patents, trademarks, trade secrets, and copyrights, as provided in § 5 of this Contract;
- 26.2 For damages arising out of death or bodily injury or property damage, no limitation; and;
- 26.3 For all other claims, damages, loss, costs, expenses, suits or actions in any way related to this Contract, regardless of the form of such actions, the Contractor's liability shall not exceed five (5) times the NTE amount. Notwithstanding the foregoing, the Contractor's liability for third-party claims shall be unlimited.
- 26.4 For damages arising out of a cyber breach, defined as a breach resulting in actual or potential harm to the AOC's network, hardware, software, or other information systems.

**27. Public Access to Judicial Records**

The AOC provides public access to records in accordance with Title 16, Chapter 900 of the Maryland Rules. If a request is made to review any records pertaining to this contract, the Contractor may be contacted by the AOC, as circumstances allow, to express its views on the availability of requested information. The final decision on release of any information rests with the AOC.

**28. Conflict of Interest**

- 28.1 "Conflict of interest" means that because of other activities or relationships with other persons, a person is unable or potentially unable to render impartial assistance or advice to the State or the AOC, or the person's objectivity in performing the contract work is or might be otherwise impaired, or a person has an unfair competitive advantage. "Conflict of interest" includes pending litigation in the Maryland courts.
- 28.2 "Person" includes a contractor, consultant, or subcontractor or sub consultant at any tier, and also includes an employee or agent of any of them if the employee or agent has or will have the authority to control or supervise all or a portion of the work for which a bid or offer is made.

- 28.3 The Contractor warrants that, except as disclosed in Section 28.4 below, there are no relevant facts or circumstances now giving rise or which could, in the future, give rise to a conflict of interest.

**RECITALS**

**WHEREAS**, the Contractor and AOC have entered into Contract No. **KXX-XXXX-XX\_** (the “Contract”); and

**WHEREAS**, in order for Contractor to perform the work required under the Contract, or in the course of that work, the Contractor, the Contractor’s subcontractors, and the Contractor’s and subcontractors’ employees and agents (**collectively the “Contractor’s Personnel”**) may come into contact with information maintained or held by the Judicial branch of the Maryland government (“Confidential Information”), including the AOC and all courts, units and departments (**collectively “the Judiciary”**); and

**WHEREAS**, the Judiciary, in order to comply with the law, fulfill its various missions, and enhance the safety of participants in the judicial process, must ensure the confidentiality of certain information, and, to that end, must act as the sole entity with the authority to determine which information held by the Judiciary may be disclosed to persons or entities outside of the Judiciary; and

**WHEREAS**, Contractor acknowledges that Contractor’s compliance with this Agreement is a condition of doing business with AOC,

**NOW, THEREFORE**, Contractor agrees as follows:

1. “Confidential Information” includes any and all information provided by or made available by the Judiciary to Contractor’s Personnel in connection with the Contract, regardless of the form, format, or media on or in which the Confidential Information is provided and regardless of whether any such Confidential Information is marked as such or disclosed deliberately or inadvertently. Such information is Confidential Information, whether or not its contents may also be gathered from other sources or may subsequently be disseminated to the public. Confidential Information includes, by way of example only, information that the Contractor’s Personnel sees, views, hears, takes notes from, copies, possesses or is otherwise provided access to and use of by the Judiciary, whether the information relates to the Contract or the Contract has placed the Contractor’s Personnel in the position to receive the information. Confidential information further includes information both held by the Judiciary and derived or created from information held by the Judiciary.
2. Contractor’s Personnel shall not, without the AOC’s prior written consent, copy, disclose, publish, release, transfer, disseminate, use, or allow access for any purpose or in any form, any Confidential Information, except for the sole and exclusive purpose of performing under the Contract and except for



disclosures to such Judiciary employees whose knowledge of the information is necessary to the performance of the Contract. Contractor shall limit access to the Confidential Information to Contractor's Personnel who: 1) have a demonstrable need to know such Confidential Information in order to perform Contractor's duties under the Contract and 2) have agreed with Contractor in writing to be bound by the disclosure and use limitations pertaining to the Confidential Information. The names of Contractor's Personnel are attached hereto and made a part hereof as Exhibit 1. 3. Contractor shall require each employee, agent, and subcontractor whose name appears on Exhibit 1 to sign a writing acknowledging receipt of a copy of and agreeing to comply with the terms and conditions of, this Agreement. Subcontractors shall expressly agree to all of the terms applicable to Contractor. Accordingly, subcontractors must require their employees and agents to sign such a writing and must submit those individuals' names to the Contractor for inclusion on Exhibit 1. Upon the Procurement Officer's request, Contractor shall provide originals of all such writings to the AOC. Contractor and subcontractors shall update Exhibit 1 by adding additional names as needed and shall ensure that no employee or agent comes into contact with Confidential Information before that person has signed this Agreement. This Agreement shall not be construed to create an employment relationship between AOC and any of Contractor's or subcontractors' personnel.

4. If Contractor intends to disseminate any portion of the Confidential Information to non-employee agents who are assisting in Contractor's performance of the Contract or who will otherwise have a role in performing any aspect of the Contract, Contractor shall first obtain AOC Contract Manager's written consent to any such dissemination. AOC's Contract Manager may grant, deny, or condition any such consent, as it may deem appropriate in the AOC Contract Manager's sole and absolute subjective discretion.

5. Contractor shall hold the Confidential Information in trust and in strictest confidence, adopt or establish operating procedures and physical security measures, take all other measures necessary to protect the Confidential Information from inadvertent release or disclosure to, or theft by, unauthorized third parties, and prevent all or any portion of the Confidential Information from falling into the public domain or into the possession of persons not bound to maintain the confidentiality of the Confidential Information.

6. Contractor shall promptly advise the AOC Contract Manager in writing if Contractor learns of any unauthorized use, misappropriation, or disclosure of the Confidential Information by any of Contractor's Personnel or the Contractor's former Personnel. Contractor shall, at its own expense, cooperate with AOC in seeking damages and/or injunctive or other equitable relief against any such person(s).

7. Upon the earlier of AOC's request or termination of the Contract, Contractor shall, at its own expense, return to the AOC Contract Manager, all copies of the Confidential Information, no matter how formatted or stored, in Contractor's and/or Contractor's Personnel's care, custody, control or possession.

8. A breach of this Agreement by the Contractor or noncompliance by Contractor's Personnel with the terms of this Agreement shall also constitute a breach of the Contract. The termination of the Contract does not terminate Contractor's obligations under this Agreement.

9. Contractor acknowledges that any failure by the Contractor or Contractor's Personnel to abide by the terms of this Agreement may cause irreparable harm to the Judiciary and that monetary damages may be inadequate to compensate the Judiciary for such breach. Accordingly, the Contractor agrees that the AOC may, in addition to any other remedy available to AOC under Maryland and any applicable federal law, seek injunctive relief and/or liquidated damages of \$1,000 for each unauthorized disclosure. Contractor consents to personal jurisdiction in the Maryland State Courts and to the application of Maryland law, if AOC so elects in its sole discretion, irrespective of Maryland's conflict-of-law rules. If the Judiciary suffers any losses, damages, liabilities, expenses, or costs (including, by way of example only, attorneys' fees and disbursements) that are attributable, in whole or in part, to any failure by the Contractor or any of the Contractor's Personnel to comply with the requirements of this Agreement, the Contractor shall hold harmless and indemnify the Judiciary from and against any such losses, damages, liabilities, expenses, and/or costs.

10. The parties further agree that 1) Contractor's rights and obligations under this Agreement may not be assigned or delegated, by operation of law or otherwise, without AOC's prior written consent; 2) the invalidity or unenforceability of any provision of this Agreement shall not affect the validity or enforceability of any other provision of this Agreement, which shall be construed to provide the broadest possible protection against the disclosure of Judiciary information; 3) signatures exchanged by facsimile are effective for all purposes hereunder to the same extent as original signatures; and 4) the Recitals are not merely prefatory but are an integral part hereof.
