Hello Judiciary Employees,

As we have previously announced, for the weeks of 12/07 and 12/14, CONNECT will offer a variety of in-person training opportunities. These will include full 3-day classroom sessions, role specific ½ day sessions, and Hands-On Workshops for you to receive personal attention on specific questions about CONNECT.

Below is a breakdown of the different sessions, as well as access to the Sign-Up Genius site for each registration (click on the link next to the title of each training). Registration is on a first-come basis. All sessions will be hosted at the JECC on the lower level.

You will learn all of the details about employee and manager processes in CONNECT, as well as many background HR processes to help you understand the system. The curriculum will focus on:

- Employee processes (Completing timesheets, Absence Requests, Performance Appraisals, Personal Information Updates, etc.)
- Supervisor/Manager processes (Approving timesheets, Approving Absence Requests, Addressing Human Resources Requests, Recruiting, Delegation, etc.)
- Practice exercises in the system

This is a 3.5 hour instructor-led class that will deep-dive into to the Manager-related activities in CONNECT. It will be extremely hands-on and interactive.

- Participating in the recruiting processes
- Performance Appraisals and the Performance Management process

This is a 3.5 hour instructor-led class that will cover the more common activities that employees will perform in CONNECT. It will explore different process scenarios and provide hands-on experience through exercises.

- Requesting Comp Time
- Performance Appraisals and the Performance Management process
- Updating your Personal Information & Personal Profile in CONNECT
