Questions for Parking Lot J.

1.	Questions: Response:	What would be the hours of operation? All work shall be accomplished overnight after 6:00 P.M and before 6:00 A.M.
2.	Question: Response:	Are their site drawing of the parking lots? No, we do not have site drawings to provide.
3.	Question: Response:	How many inches requested? Overlay the existing parking lot with 2"-3" of new surface course asphalt.
4.	Question: Response:	Are the parking lots marked, Can we re-measure each lot? Yes, each lot is outline with white markings. Yes, Attendees have permission to re-measure.
5.	Question: Response:	Are testing specs required? No, not needed.
