This Addendum is being issued to amend and clarify certain information contained in the above named RFB. All information contained herein is binding on all Offerors who respond to this RFB. Specific parts of the RFB have been amended. The following changes/additions are listed below; new language has been underlined and language deleted has been marked with a ~~strikeout~~ (ex. ~~language deleted~~).

1. Revise Section A - General (Section II Specifications), as follows:

A. General

The Maryland Judiciary is seeking competitive sealed bids to purchase Twenty-Six (26) Kodak i610 Scanners with a One (1) Year Warranty.

Installation and on-site training must be included with each of the twenty-six (26) Kodak i610 Scanners.

Trade-in must include pick-up and removal of ten (10) existing Kodak 3500 Scanners.

Equipment must be new. Used or refurbished equipment is not acceptable.

Equipment shall be in accordance with the attached specifications and the Maryland Judiciary's Terms and Conditions.
