WHERE CAN A MARYLAND BUSINESS LICENSE BE OBTAINED?

A Maryland State Business License is obtained from the Clerk's Office of the Circuit Court in the county where the business is located.

How long is the License Valid?

- The business license year runs from May 1st through April 30th of the following year.
- Licenses are required to be renewed by May 1st of each year.

WHO NEEDS A BUSINESS LICENSE?

A Business License is issued by the State of Maryland and is required for <u>most</u> of the businesses in Carroll County.

- Business activities that require licenses include, but are **not** limited to:
 - Retailers and Wholesalers (requires trader's license)
 - Online Retailers with stored inventory (requires trader's license)
 - Amusements
 - Auctions
 - Chain stores
 - Construction
 - Dry cleaners
 - Garages
 - Hawkers, Peddlers and Junk Dealers
 - Plumbers and Gas Fitters
 - Restaurants
 - Storage warehouses
 - Vending Machines and Retail / Vending Businesses which sell cigarettes and E cigarette devices

TRADER'S LICENSE

A Traders License is required for buying & re-selling goods. It is for both Retailers and Wholesalers.

- ► The fee for the trader's license is based on the value of the commercial inventory that a business reports on their personal property return which is filed with the Maryland Department of Assessments and Taxation [MDAT].
- <u>Exemptions</u> to the trader's license requirement exist for the following:
 - Growers, Makers or Manufacturers of Goods
 - Businesses that are determined by the IRS to be nonprofit 501c3 status
 - Private individuals who conduct a public sale of personal effects on their property, provided that no more than one sale is conducted for a period not to exceed 14 consecutive days.

A Traders License <u>CANNOT</u> be issued in Maryland if a business:

- ► Fails to register the trade/corporate name with MDAT. To register with MDAT, please call 410-767-1184.
- ► Fails to file a personal property return with MDAT. To check status of a return, please call 410-767-1184.
- ► Fails to report commercial inventory on the personal property return
- Has unpaid personal property taxes and /or unpaid late filing penalty
- ► Has had a charter forfeited by MDAT. *Please* call **410-767-1340** to request information & instructions to revive the charter.
