### Questions/Responses No. 1 to the Request for Proposals (RFP) K20-0015-29 JIS Security Control Assessment

Ladies and Gentlemen:

The following questions for the above referenced RFP were received by e-mail and are answered and posted for all prospective Offerors. The statements and interpretations contained in the following responses to questions are not binding on the Maryland Judiciary unless the RFP is expressly amended. Nothing in the Maryland Judiciary's response to these questions is to be construed as agreement to or acceptance by the Maryland Judiciary of any statement or interpretation on the part of the Offeror asking the question.

1. Question: Is Task 1, external facing logical and physical IT infrastructure assessment to be uncredentialed or do you seek both uncredentialed and credentialed?

11. Question: Page 25, Financial Capability and Insurance. We are a privately held corporation and do not release detailed financial statements. In lieu of profit and loss statements and balance sheets will you accept a Supplier Qualifier Report from Dun and Bradstreet?

**Response: Yes, we will accept it.**

12. Question: Page 25, Financial Capability and Insurance. This heading mentions “insurance” but nothing is said about what is wanted in this section as it relates to insurance – please clarify.

**Response: Please refer to section 2.12.4 of the RFP- JIS Security Control Assessment.**
