#### Who

Reach out to local legal services providers, public services providers, and nonprofit organizations. Connect with local entities including public school systems, police and sheriff's departments, and local government entities.

#### What

Build relationships with local partners by meeting with leadership and providing print and online content on a regular basis. Explain programs and services in detail so partners can make appropriate referrals. Provide examples of suitable referrals and how your program can assist litigants without counsel. Provide a contact for organizations in case they have questions or concerns about the services provided.

#### When

Contact partners at least twice a year to provide materials. Reach out more frequently if there are significant staffing changes, or if the scope of services changes.

#### Why

Connect with other entities that serve similar populations to increase awareness about your program. Making connections will also build a network of third-party validators who can vouch for your program, help build credibility and trust, and provide invaluable "word of mouth" advertising.
