As such, **court entry is still by appointment/ hearing notice/ summons only**. Please call **410-228-0481** to make an appointment with the Clerk's Office if you need to file paperwork as we are limiting persons to one customer/ household/ case at a time.

Dorchester has been on MDEC (Odyssey) since December 19, 2016. Therefore, attorneys must continue to use the online MDEC portal for judicial filings. Filings for land records recordings should continue to use Simplifile. For self-represented parties who have not registered as a user in MDEC (optional), please continue to file and record the safest way through the United States Postal Service, UPS, Federal Express or other overnight carrier.

A drop box is available at the front of the Court House between 8:30 am - 4:30 pm for filings and Jury paperwork. Please make sure your name and telephone number are on the paperwork for questions if necessary. You may also contact the Clerk's Office M-F by telephone at **410-228-0481** between 8:30 am - 4:30 pm for any questions concerning Court operations. You can also access the daily docket online at <u>www.mdcourts.gov/clerks/dorchester/dockets</u> - Daily Docket. The next day's docket is posted by 4:30 p.m. each business day.

If you would like to **request a video conference/ hearing** for your case in which you **already have a scheduled date**, please contact the court as soon as possible to make that request. We will try to accommodate all requests if permissible and feasible:

Jury trials will not resume until, at the earliest, **October 5, 2020**. Please continue to call the Jury Commissioner at **410-228-9840** for questions and use the drop box or mail any documentation required.
