**ORDERED**, by the Court of Appeals of Maryland, that in accordance with Maryland Rules 19-409(c)(5)(D) and 19-503(c)(4), the attorneys designated in the attached list be, and they are hereby, decertified and prohibited from practicing law in the State of Maryland, for failing to file the reports indicated; and it is further

**ORDERED**, by the Court of Appeals of Maryland, that in accordance with Maryland Rule 19-606(b)(2), the attorneys designated in the attached list be, and they are hereby, temporarily suspended and prohibited from practicing law in the State of Maryland, for failing to pay the amount in full due to the Client Protection Fund as stated in the invoice, any penalty for late payment, or any charge for a dishonored check or money order, or, who failed to supply the Client Protection Fund a required social security number or federal tax identification number or statement that there is no such number, as indicated; and it is further

ORDERED that the Clerk of this Court shall notify the clerks of the Court of Special Appeals, the several circuit courts of the counties and Baltimore City, the Chief Clerk of the District Court and the Register of Wills for each county in Maryland.
