ORDER

By the Court's April 7, 2011 Order, attorney Traci L. Hughes (AIS No. 0106200117) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Hughes has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Hughes's compliance with Rule 19-605.

By the Court's September 18, 2014 and March 26, 2015 Orders, attorney Schwanda T. Rountree (AIS No. 0306180223) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rules 19-409, 19-503 and 19-605. Attorney Rountree has now requested reinstatement pursuant to Rules 19-409(c)(5)(F), 19-503(c) and 19-606(c), and the Administrative Office of the Courts and the Trustees of the Client Protection Fund have confirmed attorney Rountree's compliance with Rules 19-409, 19-503 and 19-605.

By the Court's May 7, 2020 Order, attorney Angela M. Lowery (AIS No. 9106200173) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rules 19-409(c) and 19-503(c). Attorney Lowery has now requested reinstatement pursuant to those Rules, and the Administrative Office of the Courts has confirmed attorney Lowery's' compliance with Rules 19-409(c) and 19-503(c).

By the Court's March 24, 2022 Order, attorney Lindsay R. Capodilupo (AIS No. 0812160120) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Capodilupo has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Capodilupo's compliance with Rule 19-605. According to the Administrative Office of the Courts, attorney Capodilupo has not complied with the obligations imposed by Rules 19-409 and 19-503.

Accordingly, it is this 29th day of August 2023, by the Supreme Court of Maryland, ORDERED that attorney Capodilupo (AIS No. 012160120) is reinstated pursuant to Rules 19-605 and 19-606(c) but remains temporarily suspended pursuant to Rules 19-409(c)(5)(F) and 19-503(c)(6)(A); and it is further

ORDERED that attorneys

Tarci L. Hughes (AIS No. 0106200117),

Schwanda T. Rountree (AIS No. 0306180223), and

Angela M. Lowery (AIS No. 9106200173)

are restored to good standing by the Court and are again permitted to practice law in the State of Maryland; and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Clerk of the Appellate Court of Maryland, the clerks of the circuit courts for the counties and Baltimore City, the Chief Clerk of District Court of Maryland, the Clerk of the Supreme Court of the United States, the Clerk of the United States Court of Appeals for the Fourth Circuit, and the Clerk of the United States District Court for the District of Maryland.
