ORDER

By the Court's May 1, 1990 Order, attorney Deborah Briceland-Betts (AIS No. 8706010045) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Briceland-Betts has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Briceland-Betts's compliance with Rule 19-605.

By the Court's March 20, 2014 and March 26, 2015 Orders, attorney Michael E. Tankersley (AIS No. 8612010508) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Tankersley has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Tankersley's compliance with Rule 19-605.

By the Court's September 17, 2015 Order, attorney Blair D. Parker (AIS No. 1312180327) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rules 19-409(c) and 19-503(c). Attorney Parker has now requested reinstatement pursuant to those Rules, and the Administrative Office of the Courts has confirmed attorney Parker's compliance with Rules 19-409(c) and 19-503(c).

By the Court's March 21, 2024 Order, attorney Christine A. Northern (AIS No. 8406010276) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rules 19-409(c) and 19-503(c). Attorney Northern has now requested reinstatement pursuant to those Rules, and the Administrative Office of the Courts has confirmed attorney Northern's compliance with Rules 19-409(c) and 19-503(c).

By the Court's March 21, 2024 Order, attorney Janell D. Henderson (AIS No. 1602040003) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Henderson has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Henderson's compliance with Rule 19-605.

Accordingly, it is this 14th day of August 2024, by the Supreme Court of Maryland, ORDERED that attorneys

Deborah Briceland-Betts (AIS No. 8706010045),

Michael E. Tankersley (AIS No. 8612010508),

Blair D. Parker (AIS No. 1312180327),

Christina A. Northern (AIS No. 8406010276), and

Janell D. Henderson (AIS No. 1602040003)

are restored to good standing by the Court and is again permitted to practice law in the State of Maryland; and it is further

ORDERED that the Clerk of this Court shall forward a copy of this Order to the Clerk of the Appellate Court of Maryland, the clerks of the circuit courts for the counties and Baltimore City, the Chief Clerk of District Court of Maryland, the Clerk of the Supreme Court of the United States, the Clerk of the United States Court of Appeals for the Fourth Circuit, and the Clerk of the United States District Court for the District of Maryland.
