ORDER

The Administrative Office of the Courts has certified to the Clerk of this Court that the attorneys listed in the attachment to this order are in default of duties imposed by one or more of the following Rules: Rule 19-409 (duty to file an IOLTA Report), Rule 19-503 (duty to file a pro bono legal service report), Rule 19-605 (duty to pay an annual assessment as invoiced and provide information regarding a social security number (SSN) or federal Tax Identification Number (TIN)). or TIN) are temporarily suspended and prohibited from practicing law in the State of Maryland; and it is further

ORDERED that the clerk of this Court shall provide notice of this suspension and decertification order in accordance with Rule 19-761(b) and post a copy of this Order on the Court's webpage.
