6	morning, 8:00, 9:00, 10:00, 11:00, 12:00?
7	MR. HARRIS: I don't know.
8	DETECTIVE: Give me an idea. Had school started
9	yet, was Ke'andre gonna be late for school?
10	MR. HARRIS: No, I would say it was the time of
11	8:00, I think, when kids are getting ready to go to school.
12	DETECTIVE: So would you say it was like 8:00, 7:30?
13	MR. HARRIS: Probably 7:30.
14	DETECTIVE: Okay. So you got up pretty early this
15	morning, right?
16	MR. HARRIS: (No audible response)
17	DETECTIVE: You must have gone to get breakfast
18	sandwiches, like, pretty early.
19	MR. HARRIS: Um, you know, it was the hours of
20	around 6:30 or 7:00.
21	DETECTIVE: Is that so? Okay. No, that's pretty
22	good. All right. So, some time before school starts when
23	Ke'andre has to go onto school is when Rel shows back up and
24	he chat with you. Is anybody with him? Is he by himself,
25	he's driving it?

1 MR. HARRIS: Yeah, but he was telling me and 2 Ke'andre that he was gonna met up with his homeboy Doobie 3 today. 4 DETECTIVE: Okay. Rel was gonna meet up with 5 Doobie? 6 MR. HARRIS: (No audible response) 7 DETECTIVE: Do you know Doobie's real name? MR. HARRIS: No, I don't know Doobie at all. 8 9 DETECTIVE: Have you ever met him before? 10 MR. HARRIS: Never seen him or anything. 11 DETECTIVE: Okay. All right. So, what else? What did he explain or what is going on next? 12 13 MR. HARRIS: Um --14 DETECTIVE: You said he was getting ready to 15 hookup with his boy Doobie, right? 16 MR. HARRIS: He said he was gonna be with his 17 man Doobie today, and he was -- (Inaudible - 12:09:13) --18 and I said, "You pulling shit off, get out of there." You 19 know -- (Inaudible - 12:09:18). He kept going straight 20 down the street, but once he passed Madison --21 DETECTIVE: He didn't take Ke'andre with him, 22 because that's the way Ke'andre was going. 23 MR. HARRIS: No, Ke'andre was -- (Inaudible -24 12:09:29) -- he waited until he passed Monument and 25 Streaker, then he stopped.

1 DETECTIVE: Who? 2 MR. HARRIS: Rel. 3 DETECTIVE: Okay. 4 MR. HARRIS: He stopped the jeep at the next corner, then he was waiting for me and Ke'andre to walk 5 6 down. He was calling Ke'andre's name, he stopped the jeep. 7 DETECTIVE: So when he first sees you, you talk 8 to him a little bit, and he says, "I'm gonna hang out with 9 Doobie today." He drives off and goes just a couple blocks 10 or was it one block? 11 MR. HARRIS: It was like two. 12 DETECTIVE: Okay. But you lost him, then he stops 13 and waits for you guys to catch back up, and he's yelling 14 for Ke'andre? 15 (No audible response) MR. HARRIS: 16 DETECTIVE: Okay. I follow you so far. 17 MR. HARRIS: He was trying to get me and Ke'andre 18 to get in. 19 DETECTIVE: Okay. 20 MR. HARRIS: He said he would take Ke'andre to 21 school, but Ke'andre had seen his mom and he was talking to 22 her while Rel was in the jeep. So we had walked off and 23 walked down to the orange bus stop. 24 DETECTIVE: Did Rel drive off? 25

1 MR. HARRIS: Yeah, Rel was still back there when 2 Ke'andre mom pulled right there, but he didn't know it was 3 her. 4 DETECTIVE: All right. 5 MR. HARRIS: I don't know if she knew, because if she knew she would have said something. 6 7 DETECTIVE: Does she not like Rel? 8 MR. HARRIS: No, she do like Rel. 9 DETECTIVE: She would said something because she knows him? 10 11 MR. HARRIS: Yeah. 12 DETECTIVE: Okay. I follow you. I follow you. 13 MR. HARRIS: Once we got to the bus stop, the bus 14 came right away. 15 DETECTIVE: So, Ke'andre didn't get in the car 16 with his mom? 17 MR. HARRIS: No. 18 DETECTIVE: Did she eventually drive off? 19 MR. HARRIS: Yeah. 20 DETECTIVE: Okay. Did she stop at all and talk 21 to you? 22 She go right past, but that's when MR. HARRIS: 23 she had stopped, and then she backed up, and she was talking 24 to him. 25 DETECTIVE: Okay.

1	MR. HARRIS: We had told her how we were about to
2	go to the subway I mean not, subway, the bus stop, the
3	orange bus stop and we got on. As soon as we got to the bus
4	stop, the only (Inaudible - 12:11:23) but we seen Rel
5	in the jeep turning the corner, like trying to get up with
6	us. So we stayed on the bus and went onto school. Then we
7	got out of school we had seen Rel
8	DETECTIVE: So, you and Ke'andre get on the orange
9	bus, and it takes you out to Patterson High School?
10	MR. HARRIS: It takes us there.
11	DETECTIVE: Even though you don't go there, you
12	go tag along?
13	MR. HARRIS: Yeah.
14	DETECTIVE: All right. That's cool. When you got
15	out there, Rel had followed you in the jeep?
16	MR. HARRIS: When we got out there, once we got
17	off the bus, we seen Rel at the bottom.
18	DETECTIVE: Okay. At Patterson?
19	MR. HARRIS: Yes.
20	DETECTIVE: All right. So then what happens?
21	MR. HARRIS: After that, he got off the bus and
22	Ke'andre saw some of the students at his school, and I was
23	talking to some of them that I know.
24	DETECTIVE: What was Rel doing, just sitting
25	there?

1 MR. HARRIS: Rel was listening to music, but he 2 wasn't in the jeep. 3 DETECTIVE: Okay. Next to it? 4 MR. HARRIS: Yeah, next to it? 5 DETECTIVE: All right. 6 MR. HARRIS: That's when me and Ke'andre walked 7 in the front of the school, and I had gave him five and I told him, I said, "See you later" and I told him, "Be safe." 8 9 He said the same thing. Then in the morning it's a lot of 10 buses that's dropping kids off, and at the end of the day 11 it's a lot of buses that's picking the school kids up, but once I left in front of the school when Ke'andre walked in 12 13 the school, I was looking for Rel, but I didn't see him, so 14 I had got on the bus. When I got on the bus, that's when I 15 had seen him, he was swerving in front of the bus. 16 DETECTIVE: Okay. Like fooling around or what? 17 MR. HARRIS: Yeah, fooling around. 18 DETECTIVE: Was he trying to get the bus to stop? 19 MR. HARRIS: No, I think he was just probably 20 doing it. 21 DETECTIVE: -- (Inaudible - 12:13:05). 22 MR. HARRIS: Uh-huh. 23 DETECTIVE: All right. 24 That's when we had got back down MR. HARRIS: 25 there over east near the Eagle Mart.

1 DETECTIVE: Who? 2 MR. HARRIS: Me. I got off the bus at Eagle Mart. 3 DETECTIVE: Just by yourself? 4 MR. HARRIS: Yeah, I was by myself then. 5 DETECTIVE: Eagle Mart? 6 MR. HARRIS: Yeah, it's a gas station. 7 DETECTIVE: Is that a road, Eagle Mart? 8 MR. HARRIS: No, Eagle Mart is on Orleans Street. 9 DETECTIVE: Is that the name of the gas station, 10 Eagle Mart? 11 MR. HARRIS: Yeah. 12 DETECTIVE: Oh, okay. I'm not familiar with that. 13 That's on Orleans, okay. MR. HARRIS: It's down the street -- not down the 14 15 street, it's up the street from Aldi's. DETECTIVE: Up the street from what? 16 17 MR. HARRIS: Aldi's. 18 DETECTIVE: Aldi's? 19 MR. HARRIS: (No audible response) 20 DETECTIVE: Oh, okay. I know what you're talking 21 about. -- (Inaudible - 12:13:49) -- was still there? 22 MR. HARRIS: Yeah. 23 DETECTIVE: Okay. 24 MR. HARRIS: After I got off the bus I started 25 walking up towards -- (Inaudible - 12:13:58).

1	DETECTIVE: Okay.
2	MR. HARRIS: (Inaudible - 12:14:00) because
3	that's where my sister live at. I wanted her to see if she
4	could give me my father number, because I don't know it off
5	hand. He had just came home, so I was trying to talk to
6	him, but I didn't have a chance because she wasn't in the
7	house, only her mother and her stepfather was home.
8	DETECTIVE: Okay.
9	MR. HARRIS: So, I had left. As I was leaving
10	walking up Monument, I seen Rel coming down Monument.
11	DETECTIVE: He's all over the place.
12	MR. HARRIS: He's coming down Monument with his
13	homeboy Doobie.
14	DETECTIVE: So Doobie is now in the jeep with him?
15	MR. HARRIS: (No audible response).
16	DETECTIVE: Okay.
17	MR. HARRIS: After that they pulled over to the
18	side across the street from Shoppers. I believe that's
19	no, not Shoppers, Save-A-Lot, and he was across the street.
20	He parked across the street and he was like, you wanna get
21	in? At first I was skeptical of getting in, I didn't want
22	to us get caught up by the police or want to be in some type
23	of situation.
24	DETECTIVE: Did you have a feeling something was
25	up with the jeep with Rel driving and it was not his jeep?

1 MR. HARRIS: Had a feeling. 2 DETECTIVE: Okay. MR. HARRIS: When I first had asked him where he 3 4 get it from, he said his people's had gave it to him. 5 DETECTIVE: All right. That's just ridiculous, 6 right? 7 MR. HARRIS: Right. That's the part at the 8 moment, I didn't think about it. 9 DETECTIVE: Okay. 10 MR. HARRIS: I should've thought about what he 11 said, but I didn't. 12 DETECTIVE: I understand. All right. So you hop 13 in the jeep and it's you, Rel and Doobie. 14 MR. HARRIS: (No audible response) 15 DETECTIVE: All right. So I can keep this 16 straight, what's -- let me go over this. Rel, Ashford and 17 Montford. About how old is Doobie? 18 MR. HARRIS: I would say, I think 16. 19 DETECTIVE: 16, okay. What kind of hair does 20 Doobie have? 21 MR. HARRIS: Like a regular haircut. DETECTIVE: Like short kind of clean cut look? 22 23 MR. HARRIS: (No audible response) 24 DETECTIVE: All right. Any kind of braids, parts, 25 nothing fancy?

1	MR. HARRIS: (No audible response)
2	DETECTIVE: Okay. Is he tall or short?
3	MR. HARRIS: He's tall.
4	DETECTIVE: How tall is he? Is he really tall?
5	You got a guess?
6	MR. HARRIS: Um
7	DETECTIVE: What are you, 5'7", 5'8", right?
8	MR. HARRIS: (No audible response)
9	DETECTIVE: How much taller is he than you?
10	MR. HARRIS: He like 5'11" or probably 6'0".
11	DETECTIVE: Okay. What kind of build does he
12	have, thin, fat, heavy, muscular, athletic?
13	MR. HARRIS: Thin.
14	DETECTIVE: Okay. Is Doobie any of the phone
15	numbers we talked about?
16	MR. HARRIS: Um, I don't know.
17	DETECTIVE: Did you say you know who Nute is?
18	MR. HARRIS: Nute?
19	DETECTIVE: Nute's a friend of Rel's?
20	MR. HARRIS: Yeah, all I know is Nute and
21	DETECTIVE: Nute and Doobie aren't the same
22	person?
23	MR. HARRIS: No.
24	DETECTIVE: Okay.
25	MR. HARRIS: They both know Rel though.

1	DETECTIVE: Key is Ke'andre?
2	MR. HARRIS: Yeah.
3	DETECTIVE: Little Ray is
4	MR. HARRIS: Raquan.
5	DETECTIVE: Raquan, that's not Doobie?
6	MR. HARRIS: No.
7	DETECTIVE: I'm asking, is that Doobie?
8	MR. HARRIS: Uhn-uhn.
9	DETECTIVE: Then Ricky doesn't go by Doobie?
10	MR. HARRIS: Uhn-uhn.
11	
12	(WHEREUPON, a pause had in the proceedings.)
13	
14	DETECTIVE: Okay. So, all right. Let's keep
15	going. So the three of you are in the car, and what time
16	do you think it is now?
17	MR. HARRIS: Um
18	DETECTIVE: Roughly.
19	MR. HARRIS: I'm not sure.
20	DETECTIVE: Okay. Some time right after school
21	started, because at the bus stop and he shows up and you
22	got in the car with him and Doobie. Okay. Then what?
23	MR. HARRIS: I was already in the back, and
24	that's when they had stopped at a gas station and put gas
25	in the car.

1 DETECTIVE: What gas station they stop at? 2 MR. HARRIS: I don't know what gas station, but --3 DETECTIVE: Do you know where it is? MR. HARRIS: It's somewhere out here. 4 5 DETECTIVE: Somewhere out here like in the county 6 somewhere? 7 (No audible response) MR. HARRIS: 8 DETECTIVE: Okay. Do you remember what road you 9 went to get to the county? 10 MR. HARRIS: No. 11 DETECTIVE: Okay. Well, lets back up. Did you 12 pick up anybody else at some point in the car? Because 13 there's somebody else in the car. 14 MR. HARRIS: You know, I was about to get to it. 15 DETECTIVE: Oh, okay. Go ahead, I'm sorry. 16 MR. HARRIS: On the way out here he had stopped 17 at one gas station to get some gas, and then Rel and Doobie walked in. I just got out, because I didn't want to sit in 18 19 there while --20 DETECTIVE: You just got out more to --21 MR. HARRIS: Yeah. 22 DETECTIVE: -- get out of it, okay. 23 MR. HARRIS: I got out and walked to the corner. 24 That's when he had asked me what I was doing, I said, I 25 ain't doing nothing just walking to the corner.

1 DETECTIVE: Who asked you that? 2 MR. HARRIS: Rel. 3 DETECTIVE: Okay. 4 MR. HARRIS: I told him, "I'm walking to the corner, because I don't feel comfortable sitting in the 5 jeep." He said, "Why?" I said, "I just don't." He said --6 7 (Inaudible - 12:19:48), and that's when him and Doobie had 8 went into the gas station. 9 DETECTIVE: Okay. MR. HARRIS: When they came out, that's when they 10 11 had somebody else with them. 12 DETECTIVE: From the gas station? 13 MR. HARRIS: Yes. 14 DETECTIVE: Okay. What's that person's name? 15 MR. HARRIS: I don't know. I don't know his name. 16 He wasn't talking. 17 DETECTIVE: What did they call him? 18 MR. HARRIS: Rel was calling him -- I don't know, I think -- I think that person was Nute. 19 20 DETECTIVE: So did they get Nute from the gas 21 station? 22 MR. HARRIS: (No audible response) 23 DETECTIVE: All right. 24 MR. HARRIS: He got braids and -- (Inaudible -25 12:20:25).

1	DETECTIVE: Yeah, let me write that down so I can
2	keep straight. I have to keep all these people straight in
3	my head. Do you know Nute's real name?
4	MR. HARRIS: No.
5	DETECTIVE: Okay. Nute, about how old is Nute?
6	MR. HARRIS: He looked like he was 17.
7	DETECTIVE: 17 years old, about. I'm not holding
8	you to it. What kind of hair did he have, you said he has
9	braids?
10	MR. HARRIS: (No audible response)
11	DETECTIVE: Like how long?
12	MR. HARRIS: To his neck.
13	DETECTIVE: Braids to the neck, down to like the
14	bottom of his neck?
15	MR. HARRIS: Yeah, cornrows.
16	DETECTIVE: Okay. How about this, is he tall our
17	short? How do you do you think he is?
18	MR. HARRIS: Probably 6'2".
19	DETECTIVE: Super tall, okay. How about his
20	build?
21	MR. HARRIS: He's skinny.
22	DETECTIVE: Skinny.
23	MR. HARRIS: Nute and Doobie, they're both thin,
24	but it looks like they athletic.
25	DETECTIVE: They look like they're athletic?

21	on and some black jeans.
22	DETECTIVE: Okay. Then while I'm thinking about
23	it, did you have any other clothes on or you've been wearing
24	that all day?
25	MR. HARRIS: I had this on all day.

1 DETECTIVE: Okay. Did you have a jacket on at 2 any point that you took off? 3 MR. HARRIS: No, I had nothing on but this. 4 DETECTIVE: Right, your hooded zip up jacket. 5 Did you keep that on all day? Just curious. 6 MR. HARRIS: Yeah, I had it on all day. 7 DETECTIVE: You didn't have your hood on. All right. You were wearing it, but you just didn't have the 8 9 hood up. Okay. Did you ever take it off at any point? 10 MR. HARRIS: (No audible response) 11 DETECTIVE: All right. So what happens next? So 12 you pick up -- they pick up Nute at the gas station, all 13 right. 14 MR. HARRIS: We all got in -- that's when they 15 went close to the end of the exit like they were about to 16 exit the gas station, and that's when I had got in. 17 DETECTIVE: Okav. Then he pulled over to the side of 18 MR. HARRIS: 19 the street and let Nute drive, and Nute and Doobie was in 20 the front seats, and me and Rel was in the back. 21 DETECTIVE: So, Rel let's Nute drive? 22 MR. HARRIS: (No audible response) 23 DETECTIVE: Is that from the gas station or he 24 pulled over at some point and switched? 25 MR. HARRIS: From the gas station.

1 DETECTIVE: So when he first get Nute, Nute is 2 the driver now. 3 MR. HARRIS: Um, no. I'm gonna say Rel pulled 4 up from the gas station and turned the street, and then he 5 pulled over and switched. 6 DETECTIVE: Okay. So do you remember where this 7 gas station was? 8 MR. HARRIS: No. 9 DETECTIVE: Do you remember if it was --10 (Inaudible - 12:24:54) -- or what kind of gas station it 11 was, Exxon, CITCO, Shell? 12 MR. HARRIS: It didn't have anything on it. 13 DETECTIVE: You don't remember seeing anything? 14 MR. HARRIS: No, all I know is it was gas station. 15 The gas station was white and -- (Inaudible - 12:25:10). 16 DETECTIVE: Okay. So they actually sell gas, 17 there are gas pumps there? 18 MR. HARRIS: Yeah. 19 DETECTIVE: While I'm thinking about it, while you 20 guys were leaving the city and headed to the county out to 21 Perry Hall, out that way, what road did you go. 22 MR. HARRIS: Well --23 DETECTIVE: I don't expect you to know every road 24 name, but give me an idea. Did you go up 83, did you get on 25 the highway, did you go around the Beltway or did you go --

1 MR. HARRIS: No, he drove up Harford Road, that's 2 the last road that I know that I remember. 3 DETECTIVE: Did you take Harford Road all the way 4 out to the county? 5 MR. HARRIS: (No audible response) 6 DETECTIVE: Did you go to the gas station where 7 you picked up Nute, before you got to the county or after 8 you got to the county? 9 MR. HARRIS: Before, because Nute drove out 10 there. 11 DETECTIVE: So, it's probably a city gas station. 12 MR. HARRIS: I don't know. I don't know. 13 DETECTIVE: Well, if Nute drove out to the county 14 or when you stopped and picked up Nute, you probably picked 15 him up in the city or you could have picked him up in the 16 county? 17 MR. HARRIS: It probably was the city, but it didn't look like the city. 18 19 DETECTIVE: Okay. Well, don't let me put words 20 in your mouth, I'm just trying to understand. Okay? No 21 big deal. That's all right. You remember -- (Inaudible -22 12:26:25) was it Old Harford Road or definitely was not 23 Old Harford Road? 24 MR. HARRIS: I don't know, it's a possibility it 25 was Old Harford Road.

1 DETECTIVE: Okay. All right. So you pulled over 2 and now Nute's the driver. What happens next? 3 MR. HARRIS: Nute and Doobie getting talking. 4 DETECTIVE: Nute and Doobie, they're both up front. 5 Nute driving, Doobie in the passenger seat, you and Rel in 6 the back. All right. They get to talking about what? 7 MR. HARRIS: It was music on, I just heard them talking. After that, that's when --8 9 DETECTIVE: Let me assure you, if they're talking 10 about doing something bad, don't just cover it, because I 11 probably already know what they're talking about. Okay? I 12 want you to give your version of how you ended up here. I 13 already know kind of a lot of what happened here, so just 14 tell me what you heard. They get to talking in the front 15 seat. 16 MR. HARRIS: Yeah, they get to talking in the front 17 seat, but the music was on so I really couldn't understand 18 what this was saying. 19 DETECTIVE: Okay. 20 MR. Okay? So you stopped at 12 another house. How many other houses did you stop at before 13 you went to this one? 14 MR. HARRIS: They had stopped at one house. 15 DETECTIVE: Only one, you sure? 16 MR. HARRIS: Yeah. 17 Okay. What happened when you got to DETECTIVE: that house? 18 19 MR. HARRIS: Well, we wasn't -- I'm not gonna 20 say we were like in front of the house on the side. It's 21 a block, then on the side they turned right to get on that 22 block or where the house was at. I was sitting down. 3 I got in the passenger seat and sat down in the seat that --4 (Inaudible - 12:29:00) -- and I locked the doors. 5 DETECTIVE: Okay. 6 MR. HARRIS: Then I was just turning on my phone. 7 DETECTIVE: Turning on which phone? 8 MR. HARRIS: The white phone. 9 DETECTIVE: Which is actually Rel phone. 10 MR. HARRIS: Yeah. 11 DETECTIVE: Okay. What were you doing on the 12 phone at that point, did you call anybody, text anybody, 13 FaceTime anybody? 14 MR. HARRIS: No, I was on Instagram. 15 DETECTIVE: Were you on Instagram, okay. All 16 right. So were you Instagraming them? 17 MR. HARRIS: No, I was just on Instagram. 18 DETECTIVE: All right. So then what happened? 19 MR. HARRIS: After that --20 DETECTIVE: How long were they out of the car? 21 MR. HARRIS: I would say like 10 or 15 minutes. 22 Okay. You know what they're doing? DETECTIVE: 23 Not off hand, I just know that --MR. HARRIS: 24 not off hand, but to me I think it's not something that 25 you suppose to be doing, I quess.

1 DETECTIVE: Okay. Well, did you see them go up 2 to the house? MR. HARRIS: No, I just seen them park in the back 3 of another house. 4 DETECTIVE: Okay. HARRIS: So, I had pulled straight off. 24 DETECTIVE: Well, did you stop when you hit her? 25 MR. HARRIS: No, I didn't even know I hit her.

CIRCUIT COURT FOR BALTIMORE COUNTY

1 DETECTIVE: Well, you knew she was standing when 2 you put your head down. 3 MR. HARRIS: Yeah, I knew she was standing there, but I didn't know I hit her. 4 5 DETECTIVE: That's when you hit the gas, you just 6 put your head down and didn't look? 7 MR. HARRIS: No, I didn't look at anything. I was 8 too scared to look, because I didn't know if I was gonna 9 crash, hit the police car or hit the police, I didn't know 10 if I was gonna get shot or not. 11 DETECTIVE: Okay. So, when she's yelling for you to get out of the car, you open the door a little bit? 12 13 MR. HARRIS: Yeah. 14 DETECTIVE: Then you decided you were gonna close 15 the door because you wanted to get out? 16 MR. HARRIS: Yeah. 17 DETECTIVE: Okay. Then you said you were able to go around to the right side of the police car, because 18 that's where it was enough space to maneuver from, right? 19 20 MR. 20	A 27-K we can see that she's moved up enough that
21	we now have the whole side of the police front driver's
22	side, and a little bit of the back door in view, and she
23	is dropped one hand while she's moving backwards with her
24	hand with her outstretched hand in front of her.
25	Q 27-L?

1 27-L we see that she's moved back even farther. А 2 Now we have the driver's door, rear door and the rear tires 3 beginning to come into view while the jeep is getting even 4 closer. 5 27-M? 0 6 27-M we can see that she's moved back even А 7 farther. Now we have the whole back of that corner of the 8 police car in view, and the jeep has come up so close that 9 it's pushing against her hand. You can see the fingers 10 flexed back and the wrinkles in the hand. 11 27-N? 0 27-N the jeep has stopped and she's able to put 12 Α 13 that hand back up with the other hand. 14 27 - 0?Ο 15 27-0 she's moved a little bit farther. А 16 27-P? 0 17 27-P is a little bit farther, not too much from А 18 the last one. 19 She's getting more behind her car at this point? 0 20 Yeah, you can use the center antenna, this right А 21 here, for communication with the com center as kind of a 22 That's about the center of the rear trunk. qauge. 23 27-0? Q 24 27-Q, here we see the jeep has now lunged forward Α 25 again, and her hand is being pushed against the fender.

1	Q What, if anything, do you see about the door of
2	the jeep?
3	A The door right here at this point is just barely
4	open a little bit.
5	Q 27-R?
6	A 27-R we see that the door is coming open a little
7	bit further.
8	Q 27-S?
9	A 27-S we see the door's almost fully extended open.
10	Q 27-T?
11	A 27-T we see that the door has been shut, and the
12	jeep is moving forward. You see her hand here, it's flexed
13	even more than it was before. You can see the wrinkles on
14	her left hand against the front of the jeep.
15	Q 27-U?
16	A 27-U, now we can see that the jeep is pressing
17	completely against her hand where it's flattened out against
18	the front of the grill, and she's just above the front
19	her hand is just above the top of the front of the hood.
20	Q What, if anything, do you note regarding firearm?
21	A Her firearm is in this one in just her right hand,
22	and it appears that we have the beginning of the firing of
23	the weapon, because we see this right here that looks kinda
24	like a smudge, but it's actually the gunpowder and smoke

1 The other thing is just kind of MR. BROWN: 2 novel, because it's already been admitted into evidence, 3 but that is we're talking about the tape or body-worn camera 4 of Officer Caprio. So 6 the video doesn't lend itself as to whether or not he's 7 quilty of the burglary, because that's the only issue at this point, initially, that's the threshold. Did he commit 8 9 the burglary? Was involved in the burglary? That's what 10 they've gotta deal with. We already know about the death, 11 we have the death certificate -- I mean, the autopsy report. 12 So now we're putting in and we're sending back potentially 13 to the jury and the State may want to play it, I imagine, 14 in closing argument, and it is highly prejudicial, but it's 15 not probative of one iota, nothing. It's not probative of 16 anything.

17 Since we argue it's a novel situation, because 18 if it was known at the time that this was felony murder, 19 we would have objected to it coming in. Why? Because the 20 autopsy establishes death, then now the question is burglary 21 participation. So they had the option of going with either 22 premeditated or felony murder, we go through the entire case 23 and they decide to jettison the premeditation which dealt 24 with the intent, did he mean it or not, and just deal with 25 felony murder.

1 We know there was a death, got that. We don't 2 need that video being viewed again to prove that issue. 3 We have the autopsy. So the only issue is burglary. The 4 verdict sheet even reads: Count 1, burglary of this home; 5 Count 2, burglary of this home. If you find him not quilty 6 of those burglaries skip felony murder, don't even deal with 7 it. So that's why at this point this has become a burglary 8 trial, and the body-cam footage lends nothing to that issue 9 of whether a burglary was committed.

The death is established by the autopsy, and I know it's in evidence, but still I just think at this point it's highly prejudicial and it continues to be. I mean, if you watch it a thousand times, it's prejudicial each. You will never get numb by it. It's very sensitive, it hits a nerve each and every time. So I would ask that the State be proscribed from using it their closing argument.

You see Harris at the Fuel 15 Source in the jeep, 11 minutes later the jeep is on Ardmore. 16 Kenneth Chambers saw four silhouettes in the jeep. GPS 17 shows they stay on Ardmore. Harris' statement, he puts 18 himself in the jeep at the gas station and he never told you 19 once that he got out of the jeep. 20 Accomplice liability. The State has to prove 21 that the Defendant with the intent to make the crime hap-22 pen, knowingly aided, counseled, command, encouraged the 23 commission of the crime. Communicated a willingness to 24 participate, ready, willing and able to lend support if 25 needed. That jeep is at the ready moving back and forth.

Evidence, not statements from attorneys. There is no evidence that Harris was in the back seat listening to music at Ardmore. Did Harris know what was gonna happen? What was the plan for the day? This is all the circumstantial evidence you need to consider when you go back into the Jury Room.

7 One crime, maybe the fourth-degree burglary 8 on Ardmore. Planned events, intent to commit 13 the burglaries.

14 They're going to addresses where none of them 15 live. They're coming away from those addresses with 16 property that they didn't have before; packages, boxes, 17 bags of money. So he's clearly present at Ardmore. Why lie? Why not mention it to you ladies and gentlemen. He never said one word to you about Ardmore but, yet, those dishes are recovered in the jeep that he's driving. You can't look into his head, but the course of his actions throughout the course of the day shows a series of planned burglaries. Who did it? They all did it.

7 Northwind. Donald Williams sees the jeep between 1:30 and 2:00 in the driveway, a man with an orange shirt. 8 9 The clock is broken at 1:35 p.m. What crime was committed? 10 Breaking, entry, taking property that does not belong to 11 them, that crime is a first-degree burglary. You clearly 12 see the evidence of breaking, the entry into someone's home 13 done with the intent to commit a theft, a theft that was 14 accomplished. Their property was taken out of there. The 15 Defendant or his accomplices broke in. Proven. That crime 16 is proven.

17 Who did it? Ward -- you see Ward's phone at 18 Northwind. Ladies and gentlemen, in the Defendant's 19 statement, he puts Ward's cell phone in his own hands at 20 Northwind. Matthews' cell phone is at Northwind. Genius' 21 cell phone is at Northwind. His phone is broken, it can't 22 be mapped, but what you do see is this GPS, Ward's GPS at 23 1:05 p.m. they are out front of Northwind. Still at North-24 wind 1:15, 1:29 still at Northwind. They are there for 42 25 minutes, 42 minutes.

The Defendant wants you to think he has no idea what's happening for 42 minutes. Property getting loaded into that jeep. He admits he's at this location. The coins in his pocket when he's arrested is from the Northwind burglary by his own statement.

Ward's 18 fingerprints are on this box, but Harris' fingerprints came 19 packed in that box.

Ladies and gentlemen, to suggest that he's not a primary actor is absurd, that's how the box was found in the jeep. The only way to get to the games is to pull everything out. Primary actor. He would have had to do some deep digging to get to that game, or he was in Northwind and he took it their basement.

1 Fingerprint on the game from Northwind, the 2 proceeds of the crime, helped himself to, primary actor or 3 accomplice liability. He had the intent that these crimes 4 happen, knowingly aided, abetted, counseled, that these 5 crimes happened. Who did it? They all did it. 6 3 Linwen Way, you see the breaking, the safe 7 thrown down the stairs. Kirsten Roller heard that bang. 8 Handgun taking, ransacking. What crime? Ladies and gentle-9 men, that is a first-degree burglary, proven. That crime, 10 proven. Who did it? Kirsten Roller, she testified, and you 11 heard her and her 911 call. All four of them got out of the 12 jeep. Ward's GPS at 1:52 at 3 Linwen Way. 13 By 2:11 Officer Caprio is arriving at the scene, 14 that's when her body-worn camera activates. They are in 15 North -- they are are in Linwen Way, excuse me. Ward's GPS 16 leaves the scene one minute and thirty seconds after Officer Caprio arrives on the scene. They are out of that house 17 18 before Officer Caprio was killed. 19 James Kolb saw the three, one in the orange shirt. 20 They're behind Linwen Way. They are leaving, coming onto 21 Lona Court before Officer Caprio was killed, before the shot 22 is fired. Why is that significant? It's the communication 23 between the team, ladies and gentlemen. Mr. Kolb follows 24 those three after he hears the shot. He believes something 25 has happened. He thinks that they've blown up mailbox.

1 He doesn't see them, but what does he see? A 2 different black male walking towards Lona Court towards 3 Linwen, with either a cell phone in his hand or his hand to 4 his head. Who did it? Matthews latent fingerprint is on 5 the TV and kitchen door at Linwen; Genius' latent finger-6 print on the front door and side of the safe at Linwen; 7 Ward's latent print on the gate at the rear deck at Linwen. 8 Ladies and gentlemen, this is now Ward's phone in Harris' 9 hands at Linwen.

10 Who did it? Ladies and gentlemen, Matthews and 11 Genius are wearing the stolen backpacks with stolen proceeds 12 The guy in the back seat had the magazine from the in it. handgun and threw it out the window, that's Ward. Ladies 13 14 and gentlemen, this is what Kirsten Roller saw happening, 15 checking to see if anyone was at the first front door. This is her photograph. Ladies and gentlemen, that's not Ward, 16 17 that's not Matthews, that's not Genius, his black jacket is 18 in the jeep. That's Harris. Evidence of his participation 19 in this burglary.

Who did it? This jeep is not idly sitting by. This jeep is not sitting stationary. There's nobody in the passenger seat listening to music. Look at the jeep. Down towards Lona Court, watch it move. It now moves further. It's ready, willing and able to assist the crime. Most, again, in fronts of Linwen ready, willing, able.

1 Who did it? Intent to make the crime happen. 2 The get-away driver ready, willing and able. The get-away 3 driver. Who do you give a working cell phone to? These are Ward's cell 7 phone records -- or actually the extraction. This is on the 21st, 1:43, Nute calling Ward's phone in Harris' hands; 1:40 8 9 Ward's phone in Harris' hands is calling Matthews; 2:09 in-10 coming from Nute to the Ward phone in Harris' hands. Ladies 11 and gentlemen, constant communication.

12 Ladies and gentlemen, right here Officer Caprio 13 is on the Court at 2:11. Calls, "Cops are here." Evidence of his intent and his participation in this crime. 20 State of mind intent. You can't look in his head, 21 but it's absolutely clear from his actions what his intent 22 If he's not part of this crime, why even drive away? was. 23 Well, officer, my friends are here, they're at a house, all 24 good. He can't do that, because he knows that's not the 25 truth.

1 First-degree felony murder. It's not necessary 2 for the State to prove the Defendant intended to kill. The State has to prove that others participating in the crime 3 4 with the Defendant committed a felony, and that felony is first-degree burglary; the Defendant killed Officer Caprio; 5 6 the act resulting in the death of Officer Caprio occurred 7 during the escape of the felony first-degree burglary. 8 Felony murder.

9 Ladies and gentlemen, the law recognizes a 10 principle that when you engage in an apparently dangerous 11 felony, although you intended to commit just the felony, 12 the burglary, and the plan wasn't to kill, because a burg-13 lary is so dangerous, the law recognizes that a killing 14 is a foreseeable circumstance when you're involved in a 15 felony first-degree burglary.

1 Who did it? Harris in his statement says he 2 was laying in the passenger seat with his head back. Well, 3 that's not true. As soon as Officer Caprio pulls in, that 4 jeep flies out of there. There's no transferring of seats, 5 he pulls out as she pulls in. Ready and able to give aid. 6 As the police are pulling up, Harris has numerous calls 7 between he and Matthews. We've talked about that. "The 8 police are here." If he didn't know what was going on, what 9 triggered these calls? 10 11 (Interview video excerpt plays at 10:50:51.) 12 13 MS. COFFIN: Okay. So, his first instinct is 14 to lie. I was out there to see a girlfriend. Well, that's 15 a lie. You lied to put distance between yourself and your 16 crime. That's a consciousness of guilt, circumstantial 17 evidence of his quilt. Why not say I was out there with 18 friends. My three friends went in the house, I was waiting 19 for them. If that's the truth, say it. He doesn't. 20 Consciousness of quilt. 21 22 (Interview video excerpt plays at 10:50:49.) 23 MR. COFFIN: Another lie, "I was going down talk-24 25 ing to my cousin, gonna meet him on the next street over."

1 Why these lies, ladies and gentlemen? He lies 2 to put distance between himself and that stolen jeep that 3 just ran over a police officer. COFFIN: Lies about how he got out there, lies 8 about who was out there, he lies to put distance between him 9 and that jeep. "Out to see a girlfriend." Distance between 10 him and the burglary. "I was out there alone. Rel didn't 11 come." Distance between him and his co-Defendants. 12 13 (Interview video excerpt plays at 10:53:36.) 14 15 MS. COFFIN: Lies. He's on the phone with Nute. 16 If he doesn't know what's happening, if he doesn't know 17 these burglaries are taking place, why create this lie? He 18 wants to put distance between himself and his co-Defendants. 19 Consciousness of quilt. 20 21 (Interview video excerpt plays at 10:54:16.) 22 23 MS. COFFIN: Lies. 24 25 (Interview video excerpt plays at 10:54:21.)

1 MS. COFFIN: He can't get around these lies. 2 3 (Interview video excerpt plays at 10:54:29.) 4 5 MS. COFFIN: He didn't wanna get caught in the 6 jeep that just ran over Officer Caprio. Ask yourself these 7 questions. The Defendant puts himself in the jeep as the 8 police are arriving. Is he 6 foot, is it a blue shirt, what 9 does it matter? Because at the end of the day what matters 10 is that the jeep fob is in his underwear. All of this is 11 diversion of your attention from the evidence. The keys are 12 in his underwear, he hides them. When the key is found his 13 first response is did you put it there? No. Lies to put 14 distance between himself and that jeep that he's driving. 15 16 (Interview video excerpt plays at 10:57:33.) 17 18 MS. COFFIN: Lies. 19 20 (Interview video excerpt plays at 10:58:29.) 21 22 Ladies and gentlemen, why would you MS. COFFIN: 23 make this lie up? I slept over with Rel, he let me put my 24 thumb print on it today -- yesterday. Why would you make 25 up the two-week lie?

1 Because he has to put distance between himself and 2 his co-Defendants. He has to put distance between himself 3 and these crimes. That's Darrell Ward on the wallpaper. 4 5 (Interview video excerpt plays at 10:59:15.) 6 7 MS. COFFIN: So first he tries to tell the 8 detective I just found that phone in the jeep, and I added 9 my fingerprint to it. Then when the detective grills down 10 you can't really do that, then you get another story. Why 11 these lies? He wants this to be random, not to be a well-12 planned crime, a crime where the get-away driver has a 13 working cell phone. 14 15 (Interview video excerpt plays at 11:00:53.) 16 17 MS. It's just a burglary, not a murder, but he goes 5 6 back for his team. He goes back for his co-Defendants. 7 Right here, ladies and gentlemen, it's just a 8 burglary, it's not a murder. Put it in park. She has not 9 drawn her weapon. He continues towards her. Ladies and 10 gentlemen, the Defense in hoping said she was responding to 11 a suspicious vehicle, and that that was incredibly important 12 to you, that that's all she knew. He's gonna run the cop over." --4 (Inaudible - 11:09:06) -- he's in custody. 5 6 (Interview video excerpt plays at 11:09:12.) 7 8 MS. COFFIN: That's an assault, Officer Caprio 9 has every right to pull her handgun. He's now a threat to 10 her, and she pulls her handgun. She didn't throw herself 11 in front of the jeep, she was doing her duty investigating 12 these crimes. She still backs up. Yes, she sought cover, 13 she could've even fired her weapon, but she still backs up. 14 Officer Caprio is doing her duty. What she does not do is 15 let him get away. 16 When he first races towards her, he wants to 17 clear her out of the road, but she stands firm with her 18 weapon doing her duty. She still backs up. He then opens 19 the door, she changes position. He's still moving towards 20 her. Look at her hand on the jeep. Policing is for the 21 brave. That's correct, she didn't run for cover, she stood 22 strong. I can't let you leave. 




