ORDER NISI

WHEREAS, as part of the regulation of the practice of law in Maryland, the Court of Appeals establishes requirements for admission to the Maryland Bar, including rules governing examinations for admission;

WHEREAS, pursuant to Maryland Rules 19-101 et seq. the State Board of Law Examiners (“Board”) is charged by the Court with administering the process for admission to the Maryland Bar;

WHEREAS, the outbreak of the novel coronavirus, COVID-19, according to guidance by the Centers for Disease Control and Prevention and the Maryland Department of Health, poses a threat of harm to individuals who congregate in large groups;

WHEREAS, the COVID-19 emergency requires measures to protect the health and safety of applicants to the Maryland Bar;

WHEREAS, on August 28, 2020, the Court canceled the in-person administration of the UBE in Maryland, previously scheduled for September 9 and 10, 2020, and ordered the Board to proceed with remote administration on October 5 and 6, 2020 of a bar examination similar in content to the UBE, developed in conjunction with bar admission authorities of other jurisdictions and the National Conference of Bar Examiners (“the October 2020 Remote Bar Exam in Maryland”);

WHEREAS, the State Board of Law Examiners, after careful consideration of their qualifications, has by report to the Court recommended that the applicants who were successful on

the October 2020 Remote Bar Exam in Maryland, named on Exhibit A attached hereto, be admitted to the Bar, conditioned upon satisfaction of the requirements of Maryland Rules 19-204 (Character Review), 19-212 (Maryland Law Component), and 19-213 (Qualifying MPRE Score Required); and

WHEREAS, the Court seeks to conduct admissions ceremonies for applicants who were successful on the October 2020 Remote Bar Exam in Maryland without undue delay, it is this 25th day of November 2020,

ORDERED, by the Court of Appeals of Maryland, as follows:

(a) Maryland Rule 19-211(a)(2) shall be and hereby is suspended as to the required passage of 30 days prior to the ratification of this Order; and

(b) the Board's recommendation shall be ratified subject to the conditions therein stated on the 16th day of December 2020, unless exceptions to the Board's recommendation of any applicant be filed on or before said date, provided a copy of this Order be published on the Maryland Judiciary website within 5 days of the date of this Order and remains on the website until ratification.
