ORDER NISI

The State Board of Law Examiners (the “Board”), after careful consideration of their qualifications, has, pursuant to Rule 19-216(f)(1), recommended that the petitioners for admission of an out-of-state attorney without examination named on Exhibit A to this order be admitted to the Maryland Bar, conditioned upon the Board’s action on the petition pursuant to Maryland Rule 19-216(e), and each applicant’s satisfaction of the requirements of Maryland Rules 19-212 (Maryland Law Component) and 19-213 (Qualifying MPRE Score).

Based on the Board’s report and recommendation, it is this 1st day of May 2023, by the Supreme Court of Maryland,

ORDERED that, subject to the conditions stated above, the Board’s recommendation will be ratified as to each listed applicant on the 2<sup>nd</sup> day of June 2023, unless exceptions to the Board’s recommendation to admit an applicant are filed with the Court before that date; and it is further

ORDERED that, pursuant to Rule 19-216(f)(2), a copy of this Order shall be posted on the Judiciary website within five days of the date of this Order and shall remain posted on the website until the Board’s recommendation is ratified.
