ADMINISTRATIVE ORDER ON OPEN WARRANTS RELATED TO PARDONED CANNABIS CHARGES


WHEREAS, Maryland Governor Wes Moore issued an Executive Clemency Order of certain convictions for cannabis possession and certain convictions of possession of drug paraphernalia as of the 17th of June, 2024; and

WHEREAS, the Executive Clemency Order provided a full pardon for certain convictions;

WHEREAS, there are open and active bench warrants which relate to convictions which have now been pardoned;

NOW, THEREFORE, I, John P. Morrissey, Chief Judge of the District Court of Maryland, pursuant to the authority conferred by Courts and Judicial Proceedings § 1-605 of the Annotated Code of Maryland, and in the interest of justice, do on this day 4th of February, 2025, ORDER

1. That active and open bench warrants in cases that relate to a cannabis possession charge that have been pardoned, or that relate to a possession of drug paraphernalia charge that have been pardoned and that are identified in the cases listed in Appendix A attached to this Order are hereby recalled;
2. The clerks of the District Court are directed to recall such warrants and send notice of recall to the proper agency; and
3. The Chief Clerk of the District Court is directed to post this Administrative Order and Appendix A on the judiciary website.
