Details to Know


Maryland state law establishes how marriage and family are defined, established, and dissolved

Maryland State law handles most processes for divorce, child custody, and child support

Federal law increasingly passes broad-level legislation within areas such as child welfare, child support services, adoption, and child protection.

- 2. My ex is several months behind on support payments. I know he earns plenty, he just doesn't want to pay. How do I get the money I need to support our children?






Practice: Using Primary Sources
