

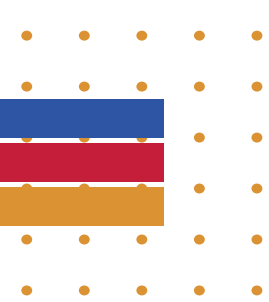

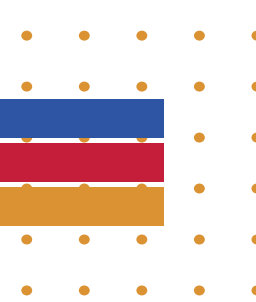

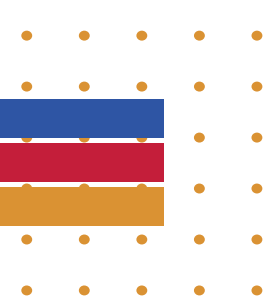

# Diversity Solicitation Forms

- Self-performing MBE primes can only perform up to 50% of an MBE goal.
- MBE contractors must be certified in MDOT.
- VSBE contractors must be certified in eMMA.

# Diversity Reporting Forms

- Both prime contractors and subcontractors must submit monthly payment reports.
- If multiple subcontractors exist, a separate monthly report must be completed for each.
- Reports are required to be submitted every month, even if no payments were made.
- Reports are used to make sure the goals are being met.
